amendment to the City's current three year labor agreement between the Pompano Beach Professional Firefighters' Local 1549 of the IAFF in the City for the term of October 2016 through September 2019. The current agreement calls for a wage reopener provision in years two and three. Recently, the City and the fire negotiating team came to a mutual agreement subject to a vote of their membership and approval by the City Commission.

Mr. Beecher noted that the City's negotiating team appointed by the City Manager and the fire union's negotiating team met on at least four occasions since August 2017. He thanked members of the City's negotiating team for their participation, Assistant

City Manager Suzette Sibble, Chief John Jurgle, Human Resources Analyst Bobby Bush, Assistant City Attorney Tracy Lyons and City Attorney Mark Berman for his counsel and input, as well as City Manager Greg Harrison, Assistant City Manager Phyllis Korab, Assistant City Manager Brian Donovan and Budget Manager Erjeta Diamanti. He also thanked the fire union team for their professionalism during the negotiations. Pursuant to the union's procedure a vote was scheduled last Wednesday and Thursday and the amendment to the agreement was approved by a majority vote of the firefighters' union.

Finally, Mr. Beecher indicated that the ordinance requires two readings and the appropriate advertisement and reading has been scheduled for the next meeting on November 14, 2017; therefore, staff has scheduled the second reading for tonight's hearing.

Mayor Fisher stated that it has been a pleasure to see the teams that have been put together over the past years working so cohesively. Conclusions are reached quickly and amicably and a fair job has been done on both sides.

Comr. Hardin concurred with the Mayor's comments and stated that in past years the situation was completely different, and gave kudos to city staff and the fire union team. Thankfully, it is a different time in the City of Pompano Beach. Everyone is working in unison to move the city forward. Great job.
