AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, AMENDING CHAPTER 34, "CITY POLICY," OF THE CITY OF POMPANO BEACH CODE OF ORDINANCES AMENDING SECTION 34.107, "POSITION CLASSIFICATION PLAN,"  $\mathbf{BY}$ RECLASSIFYING CERTAIN POSITIONS.  $\mathbf{BY}$ RETITLING CERTAIN POSITIONS; BY CREATING CERTAIN POSITIONS, AND RETITLING AND RECLASSIFYING CERTAIN POSITIONS: PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to law, ten (10) days' notice has been given by publication in a paper of general circulation in the City, notifying the public of this proposed ordinance and of a public hearing in the City Commission Chambers of the City of Pompano Beach; and
