The terms and conditions contained within the Original Agreement between CITY and CONTRACTOR, effective April 26, 2013, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect for the new contract extension term except as specifically amended hereinbelow.

- 3. The Original Agreement is amended by adding Exhibit 18, Re-turf of Nineteen (19) Putting Greens of the City of Pompano Beach Municipal Golf Course.
- 4. The parties hereto agree to extend the Original Agreement for one (1) additional five (5) year period, ending April 25, 2023.
