BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the City of Pompano Beach does hereby declare a surplus and does hereby express its desire to sell, in accordance with the provisions of the City Charter, a certain portion of land located at 1549 NW 18th Street, Pompano Beach, Florida, said property being described as follows:

SECTION 2. In accordance with Section 253 of the Pompano Beach Charter, the City Commission hereby finds, determines and declares as follows:

- A. There are no improvements located upon the above-described land.
- B. Said land has been vacant and has not been used for any purpose since conveyed to the City.
- C. Said land is not needed for public purpose since it has never been put to any public use and it is not contemplated that the property will be put to any public purpose in the reasonably foreseeable future.

SECTION 3. The City Clerk is hereby authorized and directed to advertise said property
for public sale in accordance with the provisions of the City Charter, the date of bid opening to
be, 2019, said date not being less than thirty (30) nor more
than sixty (60) days after adoption of this Resolution.
SECTION 4. This Resolution shall become effective upon passage.
