hereof as Exhibit "A," shall remain in full force and effect except as specifically amended hereinbelow.

- 3. Paragraph 7, Price Formula, to the Original Agreement shall be amended as follows:
 - 7. Price Formula. City agrees to pay Contractor for performance of the services set forth in this Agreement as follows:

An Amount Not to Exceed \$500,000.00 \$1,000,000.00.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assign and shall be fully effective as though the amendment had been originally included in the Agreement.
