
LEGAL DESCRIPTION:

BEGINNING AT THE MOST EASTERLY SOUTHEAST CORNER OF SAID LOT 1, THENCE SOUTH 69'36'53" WEST, ALONG THE SOUTH LINE OF SAID LOT 1, 20.00 FEET TO A POINT ON A LINE LYING 20.00 WEST OF AND PARALLEL WITH THE EAST LINE OF SAID LOT 1; THENCE NORTH 20'22'52" WEST, ALONG SAID PARALLEL LINE, 26.29 FEET TO A POINT ON THE NORTHERLY LINE OF SAID LOT 1, SAID LINE ALSO BEING THE SOUTHERLY RIGHT OF WAY LINE OF SW 5th AVENUE AND A POINT OF NON-TANGENCY WITH A CURVE TO THE RIGHT (A RADIAL BEARING FROM SAID POINT BEARS NORTH 14'28'08" EAST); THENCE ALONG SAID CURVE HAVING A RADIUS OF 35.00 FEET, A CENTRAL ANGLE OF 34'51'00", AN ARC DISTANCE OF 21.29 FEET TO THE NORTHERN MOST SOUTHEAST CORNER OF SAID LOT 1; THENCE SOUTH 20'22'52" EAST, ALONG THE EAST LINE OF SAID LOT 1, 20.00 FEET TO THE POINT OF BEGINNING.




