the easement area; the same rights as granted herein, to the extent that the undersigned has the power to grant, over, along, under and across the roads, streets or highway adjoining or through the said property described above; and further providing that the OWNER shall not erect or place any building or tree on the above-described real property.

As an inducement to OWNER to grant this Easement, CITY represents it is duly authorized as the exclusive water utility provider to the subject project. OWNER hereby warrants and covenants (a) that OWNER is the owner of the fee simple title to the property in which the above described Easement Area is located, (b) that OWNER has full right and lawful authority to grant and convey this Easement to CITY, and (c) that CITY shall have quiet and peaceful possession, use and enjoyment of this Easement.
