

THIRD AMENDMENT

THIS THIRD AMENDMENT is entered into on the _____ day of _____, 2019, by and between:

CITY OF POMPANO BEACH, a municipal corporation of the State of Florida, with offices located at 100 West Atlantic Boulevard, Pompano Beach, Florida, 33060, hereinafter referred to as "CITY,"

and

LIMOUSINES OF SOUTH FLORIDA, INC., a Florida corporation, with offices located at 2766 NW 62nd Street, Miami Beach, Florida 33147, hereinafter referred to as "CONTRACTOR."

WHEREAS, CONTRACTOR entered into a Service Contract ("Original Contract") with CITY to provide a community transportation service, a copy of said Original Contract adopted by Ordinance No. 2015-57 is attached hereto and made apart hereof.

WHEREAS, CONTRACTOR and CITY entered into a First Amendment to the Original Contract on October 16, 2015, and approved by Ordinance No. 2015-80; and

WHEREAS, CONTRACTOR and CITY entered into a Second Amendment to the Original Contract on June 19, 2018, and approved by Ordinance No. 2018-61; and

WHEREAS, CONTRACTOR and CITY now desire to extend the Original Contract for an additional one (1) year term.

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

2. The Original Contract effective June 26, 2015, and subsequent amendments, copies of which are attached hereto and made a part hereof as Exhibit "1," shall remain in full force and effect except as specifically amended hereinbelow.

3. The parties hereto agree to extend the Original Contract for one (1) additional one year period, ending June 25, 2020.

4. The attached Exhibit "A" is hereby substituted for, and in all references replaces, that Exhibit "A" which was attached to, referenced and made a part of the Original Agreement.

5. This Agreement shall bind the parties and their respective executors, administrators, successors and assign and shall be fully effective as though the extension had been originally included in the Agreement.
