I. MOTION REQUESTED

A) Award Request for Proposal No. RFP170384ANB Odor Control & Corrosion Services to Evoqua Water Technologies, LLC for comprehensive odor and corrosion control for the County's wastewater infrastructure on an as needed basis, as approved in the department's annual adopted budget for an initial period of three years.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the Director of Procurement Management the authority to negotiate renewals of the contract, including changes in price, for up to three additional one-year periods, and/or to extend the contract, and to execute all associated documents, with County Administration approval, as approved in the department's annual adopted budget, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Award a contract to Evoqua Water Technologies, LLC for comprehensive odor and corrosion control to minimize the adverse effects on the County's wastewater infrastructure and address nuisance odors in the system, on an as needed basis for an initial term of three years. Expenditures for these services totaled approximately \$907,802.00 during Fiscal Year 2016-2017.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

The Utilities Department submitted a request to Procurement Management to obtain proposals for the project known as RFP170384ANB Odor Control & Corrosion Services.

On the proposal deadline of December 13, 2017, the Procurement Management Department received one proposal. The proposal was evaluated on January 5, 2018; the Evaluation Committee, by super majority vote, elected to accept the proposal from Evoqua Water Technologies, LLC.
