CITY OF POMPANO BEACH, a Florida municipal corporation, whose address is 100 West Atlantic Boulevard, Pompano Beach, Florida 33060, ("CITY"),

and

EMBRACING TEAM, INC., a Florida not-for-profit corporation, whose address is 901 N.W. 10th Street, Annex Building C, Pompano Beach, Florida 33060 ("COUNTY");

collectively referred to as the "Parties."

WHEREAS, on September 30, 2016, the Parties entered into a license agreement to provide free culturally based programming for youth and seniors at Mitchell Moore Par, in its Annex Building ("License Agreement"), which was approved by City Resolution No. 2016-309; and

WHEREAS, the License Agreement is scheduled to expire September 29, 2019, and the Parties desire to extend the License Agreement for an additional year;

NOW, THEREFORE, in consideration of the mutual covenants and obligations set forth in this First Amendment, the Parties agree as follows:

- 1. RECITALS. The above recitals are true and correct and are incorporated in this Agreement.
- 2. The License Agreement, attached and made a part of this First Amendment as Exhibit "A", shall remain in full force and effect, except as specifically amended below.
- 3. The Parties agree to extend the License Agreement's term for an additional year, ending on September 29, 2020.
- 4. No other amendment to the terms of the License Agreement shall be effective unless contained in a written document executed with the same formality and of equal dignity.
- 5. This First Amendment shall bind the Parties and their respective executors, administrators, successors and assigns.
