Good Morning Mark,

Attached are two documents submitted to the City: 1) Three Party Escrow Agreement; 2) Tiger Grant Design LFA. These documents must be executed and approved by the City to allow FDOT to act on behalf of the City. As you know, the City of Pompano Beach is a member City that was recently awarded a TIGER grant. The grant resulted in \$3.5 million towards reconstruction of Phase III of the Education Corridor along MLK Boulevard from I-95 to Powerline Road. As a function of conditions of approval to receive grant funding, the member cities agreed that FDOT will be the lead agency coordinating design and construction efforts on our behalf. The Cities are responsible for matching funds (Pompano Beach's portion is \$3.5 million and any funds in excess of the \$7 million allocated to our segment due to design changes/add-ons, etc.). I have attached supporting documentation of the City's pursuit of the grant, Commission support, etc.

Please review the attached agreements and let me know if you have any concerns. I am assuming we will need one or two Resolutions to execute said agreements. Our timeline is strict. FDOT is scheduled to start design in May. Therefore, your help expediting this request will be appreciated.
