A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, ACCEPTING AN ASSISTANCE TO FIREFIGHTERS GRANT FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY AND THE DEPARTMENT OF HOMELAND SECURITY FOR THE PURPOSE OF PURCHASING HYDRAULIC PATIENT STRETCHERS AND POWER LOAD SYSTEMS FOR RESCUE/AMBULANCES; CONFIRMING THE CITY'S CONTRIBUTION; AND AUTHORIZING THE CITY MANAGER TO ACCEPT THE GRANT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Pompano Beach, Florida, has prepared an application and has been awarded a Grant from the Federal Emergency Management Agency and The Department of Homeland Security, for the purchase of three Stryker hydraulic stretchers, upgrades to four Stryker hydraulic stretchers and seven Stryker power load systems for installation in rescue/ambulances; and

WHEREAS, it is the desire of the City of Pompano Beach, Florida, to formally accept the Grant; now, therefore,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the City of Pompano Beach is hereby authorized to accept the Grant from the Federal Emergency Management Agency and The Department of Homeland Security, for the purchase of the hydraulic patient stretchers and power load systems for rescue/ambulances.

SECTION 2. The City requested Grant funds totaling Two Hundred Thousand Seven Hundred Eight and 00/100 (\$200,708.00) and was required to contribute funds of 10% of said

amount totaling Eighteen Thousand Two Hundred Forty-Six and 00/100 (\$18,246.00), which are available from the City of Pompano Beach and will remain available until needed, resulting in an award of Grant funds in the amount of \$182,462.00 to be utilized toward the purchase of the \$200,708.00.00 hydraulic patient stretchers and power load systems for rescue/ambulances.

SECTION 3. That the City Manager or his designee shall be the official liaison agent and is authorized to accept the Grant and administer the Grant for the City of Pompano Beach.
