POMPANO BEACH EAGLES, INC., a Florida not for profit corporation, having its office and place of business at 1830 NW 2nd Avenue, Pompano Beach, FL 33060, hereinafter referred to as "LICENSEE."

WHEREAS, the parties entered into an Agreement to operate the concession stand at Kester Park during the football season on September 25, 2015, ("Original Agreement"), a copy of which is attached hereto and made a part hereof as Exhibit "A," and approved by City Resolution No. 2015-425; and

WHEREAS, the parties entered into a First Amendment to the Original Agreement on September 19, 2016, approved by City Resolution No. 2016-294; and

WHEREAS, the parties now desire to extend the Original Agreement for one (1) additional one-year period ending on September 24, 2018, and change the venue of the concession stand.

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

- 1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
- 2. The original Agreement shall remain in full force and effect except as specifically amended hereinbelow.

- 3. The parties hereto agree to extend the original Agreement for one (1) additional oneyear period, ending September 24, 2018.
- 4. The operation of the concession stand at Kester Park, which is the subject of the Original License Agreement, shall be moved to North Pompano Park during the football season.
- 5. This Agreement shall bind the parties and their respective executors, administrators, successors and assign and shall be fully effective as though the extension had been originally included in the Agreement.
