

Proposed well location is a 2' by 2' square centered on a point 67.74 feet WSW at a bearing of 261.18 degrees from this point where the cul-de-sac curve meets the western property boundary. However, we may need to move the well location depending on conflicting underground and overhead utilities or other issues. The well needs to be west of the dashed plume boundary.

##### **Parcel A:**

A parcel of land in the W 1/2 of the NE 1/4 of the W 1/2 of the South 80 acres, more or less, of the NW 1/4 of Section 2, Township 49 South, Range 42 East, said parcel being more particularly described as follows:

Commencing at the Northeast corner of said W 1/2 of the NE 1/4 of the W 1/2 of the South 80 acres, more or less, of the NW 1/4 of Section 2, thence run South 0 degrees, 10 minutes, 47 seconds West (on an assumed bearing) 155 feet along the East line thereof; thence run due West 29.14 feet, to an intersection with the Westerly right of way line of Interstate Highway I-95, and the Point of Beginning; thence run South 1 degree, 39 minutes, 12 seconds, West 550.23 feet along said Westerly right of way line; thence run due West 93.93 feet, to a point of intersection with the arc of a curve running Northeasterly and Northwesterly to the left, a radial at said point bearing North 41 degrees, 15 minutes, 22 seconds West; thence along the arc of said curve to the left, having a radius of 50 feet and a central angle of 101 degrees, 53 minutes, 26 seconds, run Northeasterly and Northwesterly 88.91 feet, to an intersection with a line 201 feet East of, as measured at right angles and parallel to said West line of the W 1/2 of the NE 1/4 of the W 1/2 of the South 80 acres, more or less, of the NW 1/4 of Section 2; thence run due North 472.40 feet along said parallel line, to a point 112.74 feet due West of the Point of Beginning; thence run due East 112.74 feet, to the Point of Beginning. Said lands situate, lying and being in Broward County, Florida.

##### **Parcel B:**

A parcel of land in the West 1/2 of the Northeast 1/4 of the West 1/2 of the South 80 acres, more or less of the Northwest 1/4 of Section 2, Township 49 South, Range 42 East, being more particularly described as follows:

Beginning at the Northwest corner of said West 1/2 of the Northeast 1/4 of the West 1/2 of the South 80 acres, more or less of the Northwest 1/4 of said Section 2; thence run South 0 degrees, 10 minutes, 47 seconds West, 155 feet along the East line thereof; thence run due West 141.88 feet, to an intersection with a line 201 feet East of, as measured at right angles and parallel to the West line of said West 1/2 of the Northeast 1/4 of the West 1/2 of the South 80 acres, more or less of the Northwest 1/4; thence run due North 157.32 feet along said parallel line to an intersection with the North line of said West 1/2 of the Northeast 1/4 of the West 1/2 of the South 80 acres, more or less of the Northwest 1/4; thence run South 89 degrees, 03 minutes, 31 seconds East 142.37 feet along said North line, to the Point of Beginning. Excepting therefrom that portion thereof lying within the right of way of Interstate Highway I-95. Said lands situate, lying and being in Broward County, Florida.
