**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING 731 NW 3RD ST; ANNIE ADDERLY GILLIS PARK; THE E. PAT LARKINS CENTER; THE ALI CULTURAL ARTS CENTER; THE WEST SIDE OF THE BROWARD TRANSIT CENTER ON DIXIE HIGHWAY AND DR. MARTIN LUTHER KING JR. BOULEVARD; THE NORTH SIDE OF DR. MARTIN LUTHER KING JR. BOULEVARD AND DIXIE HIGHWAY; 3<sup>RD</sup> STREET AND FLAGLER AVENUE; THE NW CORNER OF 2<sup>ND</sup> STREET & 1<sup>ST</sup> AVENUE; 1<sup>ST</sup> AVENUE AND 2<sup>ND</sup> STREET; THE FRONT OF HOLY CROSS FAMILY MEDICAL CENTER LOCATED AT 114 N. FLAGLER AVENUE; THE FRONT OF THE BANK LOCATED AT 61 NE 1<sup>ST</sup> AVENUE; THE BAILEY CONTEMPORARY ARTS BUILDING; 50 NE 1ST STREET; THE CIVIC PLAZA; THE NORTH SIDE OF ATLANTIC BOULEVARD AND 1<sup>ST</sup> AVENUE; THE SOUTHWEST CORNER OF SW 1<sup>ST</sup> AVENUE AND ATLANTIC BOULEVARD; THE SOUTHEAST CORNER OF SW 1<sup>ST</sup> AVENUE AND ATLANTIC BOULEVARD; THE CULTURAL ARTS CENTER; CITY HALL; AND CITY COMMISSION CHAMBERS AS LOCATIONS FOR INSTALLATION OF THE MOSAIC TEAM TRAIL OF THE HONEY BEES PROJECT; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Section 160.04 of the City's Code of Ordinances, the Public Art Committee ("PAC") is empowered to make recommendations to the City Commission regarding certain public art issues, including artist selection and location of public art; and

**WHEREAS**, at its meeting on June 21, 2018, the PAC selected twenty (20) locations to be recommended to the City Commission for placement of the mosaics that are a part of the Mosaic Team "Trail of the Honey Bees" Project; and

**WHEREAS**, the twenty (20) locations recommended by PAC include 731 NW 3rd Street; Annie Adderly Gillis Park; the E. Pat Larkins Center; the Ali Cultural Arts Center; the

west side of the Broward Transit Center on Dixie Highway and Dr. Martin Luther King Jr. Boulevard; the north side of Dr. Martin Luther King Jr. Boulevard and Dixie Highway; 3<sup>rd</sup> Street and Flagler Avenue; the NW Corner of 2<sup>nd</sup> Street & 1<sup>st</sup> Avenue; 1<sup>st</sup> Avenue and 2<sup>nd</sup> Street; in front of Holy Cross Family Medical Center located at 114 N. Flagler Avenue; in front of the bank located at 61 NE 1<sup>st</sup> Avenue; the Bailey Contemporary Arts building; 50 NE 1st Street; the Civic Plaza; the north side of Atlantic Boulevard and 1<sup>st</sup> Avenue; the southwest corner of SW 1<sup>st</sup> Avenue and Atlantic Boulevard; the southeast corner of SW 1<sup>st</sup> Avenue and Atlantic Boulevard; the Cultural Arts Center; City Hall and City Commission Chambers.

**WHEREAS**, placement of the mosaics will create a visual connection between the east and west corridors of Dixie Highway in the Innovation District; now, therefore,

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:**

**SECTION 1.** That the City Commission has approved 731 NW 3rd Street; Annie Adderly Gillis Park; the E. Pat Larkins Center; the Ali Cultural Arts Center; the west side of the Broward Transit Center on Dixie Highway and Dr. Martin Luther King Jr. Boulevard; the north side of Dr. Martin Luther King Jr. Boulevard and Dixie Highway; 3<sup>rd</sup> Street and Flagler Avenue; the NW Corner of 2<sup>nd</sup> Street & 1<sup>st</sup> Avenue; 1<sup>st</sup> Avenue and 2<sup>nd</sup> Street; in front of Holy Cross Family Medical Center located at 114 N. Flagler Avenue; in front of the bank located at 61 NE 1<sup>st</sup> Avenue; the Bailey Contemporary Arts building; 50 NE 1st Street; the Civic Plaza; the north side of Atlantic Boulevard and 1<sup>st</sup> Avenue; the southwest corner of SW 1<sup>st</sup> Avenue and Atlantic Boulevard; the southeast corner of SW 1<sup>st</sup> Avenue and Atlantic Boulevard; the Cultural Arts Center; City Hall and City Commission Chambers as appropriate locations for installation of the mosaics that are a part of the Mosaic Team “Trail of Honey Bees” Project.

**SECTION 2.** This Resolution shall become effective upon passage.
