

THIRD AMENDMENT

THIS IS A THIRD AMENDMENT dated the _____ day of

_____, 2018, between:

CITY OF POMPANO BEACH, a municipal corporation of the State of Florida, whose address is 100 West Atlantic Boulevard, Pompano Beach, Florida 33060, hereinafter referred to as "CITY,"

and

CROWDER-GULF JOINT VENTURE, INC., a Florida corporation, having its office and place of business at 5435 Business Parkway, Theodore, AL 36582, hereinafter referred to as "CONTRACTOR."

WHEREAS, the parties entered into a Contract for Disaster Debris Recovery Services on September 16, 2014, ("Original Agreement"), and approved by Resolution No. 2014-309; and

WHEREAS, the parties entered into a Reinstatement and First Amendment to the Original Agreement on June 17, 2016, approved by City Resolution No. 2016-211; and

WHEREAS, the parties entered into a Second Amendment to the Original Agreement on July 28, 2017, approved by City Resolution No. 2017-291; and

WHEREAS, the CITY and CONTRACTOR have agreed to extend the Original Agreement for one (1) additional one-year period.

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

2. The Original Agreement between CITY and CONTRACTOR, dated September 16, 2014, and subsequently amended on June 17, 2016 and July 28, 2017, copies of which are attached hereto and made a part hereof as Composite Exhibit "A," shall remain in full force and effect except as specifically amended hereinbelow.

3. The parties hereto agree to extend the Original Agreement for one (1) additional one-year period, ending September 15, 2019, pursuant to the agreed terms and pricing set forth therein.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assigns and shall be fully effective as though the amendment had been originally included in the Original Agreement.
