NOVEMBER 1, 2018. No 2018 Tax Payments can be made until the actual 2018 tax bills are mailed and are available online November 1st, 2018. **DO NOT** mail early payments based on the TRIM notice of estimated taxes, as these payments cannot be accepted and will be rejected and returned.

Delinquent Tax Bills for Prior Years: No Partial Payments can be accepted for Delinquent accounts, only the full balance can be paid online and mailed partial payments will be rejected and returned.

CREDIT & DEBIT CARD FEES: Credit and Debit card transactions will be charged 2.55% of the full payment amount (\$1.95 minimum fee). You will be shown and asked to approve the amount of this NON-REFUNDABLE convenience fee before completing your payment and check-out process. **There is NO FEE** for making payment by the eCheck payment method.
