WHEREAS, James A. Crosser and Pamela G. Lamont are willing to convey to the City of Pompano Beach certain real property located at 124 S. Dixie Highway via Quit Claim Deeds in exchange for the release of two Nuisance Abatement liens resulting from Case Nos. 130110 and 152756, which total \$523.33 as of October 29, 2018; and

**WHEREAS,** the City Commission has determined that the best interests of the public will be served by accepting and acquiring the rights being conveyed by the Deeds; now, therefore,

**SECTION 1.** That the City of Pompano Beach accepts the conveyance of real property located at 124 S. Dixie Highway from James A. Crosser dated October 18, 2018 and from Pamela G. Lamont dated October 10, 2018, copies of which are attached hereto and incorporated by reference as if set forth in full, in exchange for the release of two Nuisance Abatement liens resulting from Case Nos. 130110 and 152756, which total \$523.33 as of October 29, 2018.
