Building Occupancy/Rent Storage \$13,000 pro-rated based on 28% of total sq.ft.

Utilities (FPL & Comcast) \$2,000 pro-rated based on 28% of total sq.ft.

B) Matching Funds by Clinic:

Personnel Services (Salaries & Wages): \$32,200

Medical Program Personnel to provide services to LC Pompano Beach residents:

- Advanced Registered Nurse Practitioner 4 hrs./week \$36.05 hr./45 weeks = \$6,489
- Case Eligibility Manager 10 hrs./weeks \$28.50 hr./52 weeks = \$14,820
- Medical Assistant 10 hrs./\$16 hr./52 weeks = \$8,320
- Patient Care Coordinator 4 hrs./\$12.36 hrs./week/52 weeks = \$2,571
