**A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF POMPANO BEACH, FLORIDA, CREATING A  
LOCAL COMPLETE COUNT COMMITTEE; PROVIDING  
FOR MEMBERSHIP, QUALIFICATIONS, TERMS,  
POWERS AND DUTIES; PROVIDING FOR  
SEVERABILITY; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Pompano Beach has agreed to partner with the U. S. Census Bureau in securing a complete count of all the residents in the city; and

**WHEREAS**, the U. S. Census Bureau recommends that every city and county in the U.S.A. form a complete count committee; and

**WHEREAS**, the City Commission desires to assist by creating such a committee; now, therefore,

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO  
BEACH, FLORIDA:**

**SECTION 1.** There is hereby created a Local Complete Count Committee for the City of Pompano Beach, Florida.

**SECTION 2.** The committee shall be composed of six members who shall serve without compensation at the pleasure of the City Commission. The Mayor and each City Commissioner shall be entitled to one appointment to the committee. The term of the committee members shall coincide with that of the Mayor or the City Commissioner who appointed the member.

Two alternate members shall be appointed by the City Commission for the term of the committee. In the absence or disability of a regular member, an alternate member may be called to sit and act in his place by the Chairman of the committee.

**SECTION 3.** The committee's powers and duties shall be as follows:

1. Advise the City Commission on matters relating to the 2020 U. S. Census;
2. Create awareness among the residents as to the importance of the 2020 Census;
3. Publicize the April 1, 2020 Census;
4. Develop and implement strategies for getting the residents to fill out and return the 2020 Census form;
5. Coordinate its activities with Broward County Complete Count Committee, U. S. Census representatives and local leaders from churches, schools and neighborhood associations, etc.; and
6. The committee shall select its own Chair and shall adopt rules of procedure for the conduct of the meeting provided, however, that a quorum shall require the presence of at least four committee members.

**SECTION 4.** Assistance for the committee shall be provided and coordinated through the City Manager's office and the City's Development Services Department.

**SECTION 5.** This committee shall sunset on December 31, 2020.

**SECTION 6.** If any provision of this resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this resolution that can be given effect without the invalid provision or application, and to this end the provisions of this resolution are declared to be severable.

**SECTION 7.** This Resolution shall become effective upon passage.
