GROUND LEASE AGREEMENT between DIVITO ENTERPRISES LIMITED PARTNERSHIP and CITY OF POMPANO BEACH

THIS GROUND LEASE AGREEMENT ("Agreement") made and entered into this day of 2019 (the "Effective Date"), by and between:
