RE: Street Dual Naming Request; NW 21st Avenue, Hunters Manor

Dear Mr. McCaughn:

I am submitting this letter as a request to have Northwest 21st Avenue of Hunter's Manor in Pompano dual named reflecting the legacy of my pioneering father, Rev. Daniel Miller. Northwest 21st Avenue is bordered by Atlantic Boulevard to the south and Northwest 8th Street to the north. I feel that my father's trailblazing contributions to the city of Pompano Beach are significant and worthy of such public recognition and public informing of history.

My father, the late Rev. Daniel Miller, was the first African-American General Contractor in Broward County. He laid the plans and built the homes for the Pine Tree Park subdivision, he built low income and exclusive homes from Ft. Lauderdale to Lighthouse Point and throughout Pompano Beach. He founded and pastored New Way, Covenant Missionary Baptist Church on NW 6th Street in Pompano Beach, and he was a founding member of the Pompano Beach Masonic Lodge #409 among other noteworthy, service-oriented contributions. He was also a business man who built and maintained homes throughout Pompano on NW 8th Street (Williams Subdivision), on NW 21st Avenue (Hunters Manor), on NW 7th Avenue, on NW 16th Street, on NW 27th Avenue (Collier City) and on NW 13th Street (Fords Manor). He laid out the plans for and built Jesus Supernatural Church of Deliverance on the corner of Northwest 21st Avenue and Northwest 8th Street. In fact, the subdivisions flanking the church, Hunters Manor and Williams Subdivision, are prime locations where he provided many low-income housing properties to

Pompano Beach residents in such need. His enduring legacy began in the 1950s and remains peppered throughout Broward County, Northwest Pompano Beach and Hunters Manor abutting Williams Subdivision specifically. His service and contributions to his beloved Pompano Beach community should be remembered and reflected by the renaming of 21st Avenue. My father was a productive, revered, beloved and giving community servant. He was a pastor and businessman until he passed away in 1999. It is only fitting that **NW 21st Avenue** be named for him, "**Rev Daniel Miller Ave**".
