

**SIXTH AMENDMENT**

**TO**

**AGREEMENT**

**FOR**

**POLICE SERVICES**

This Sixth Amendment is entered into this \_\_\_\_ day of January, 2020 by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Pompano Beach, FL (hereinafter referred to as the "CITY").

**WHEREAS**, on or about November 30, 2015, BSO and the CITY entered into an Agreement for Police Services; and

**WHEREAS**, on or about November 2, 2016, BSO and the CITY entered into a First Amendment to reclassify positions; and

**WHEREAS**, BSO and the CITY entered into a Second Amendment to address modifications to the pistol range; and

**WHEREAS**, BSO and the CITY entered into a Third Amendment to clarify responsibilities for the P25 Radios; and

**WHEREAS**, BSO and the CITY entered into a Fourth Amendment to add seven deputy positions and five CSA positions; and

**WHEREAS**, BSO and the CITY entered into a Fifth Amendment to reclassify a deputy position to a sergeant and an Investigative Aide position to a Crime Analyst position; and

**WHEREAS**, CITY and BSO are now desirous of adding a sergeant position, two deputy positions and reclassifying the records technician positions; and


**NOW, THEREFORE**, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. The foregoing recitations are true and correct and are incorporated by reference.
2. The staffing structure as set forth in Exhibit A of the Agreement will be modified by adding one sergeant, two deputy sheriffs and reclassifying the two District Records Specialists to one Public Records Specialist and one Records/Warrants Specialist. The Exhibit A to this Sixth Amendment is attached hereto and incorporated by reference.

3. Except as modified herein, all remaining items and conditions of the Agreement, shall remain in full force and effect.


