A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATION OF A NOT TO EXCEED AMOUNT OF FIVE HUNDRED DOLLARS (\$500.00) FOR VICE MAYOR MOSS TO SUPPORT HIS TOWN HALL MEETING EVENT ENCOURAGING VOTER REGISTRATION AND PARTICIPATION IN THE 2020 CENSUS; AND APPROVING AND AUTHORIZING THE APPROPRIATION OF A NOT TO EXCEED AMOUNT OF FOUR THOUSAND DOLLARS (\$4,000.00) FOR AN EVENT FEATURING MUSIC, REFRESHMENTS AND HEALTH SCREENING ACTIVITIES FOR RESIDENTS SPONSORED BY VICE MAYOR MOSS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 2019-50, the City has budgeted annual funds in a set amount on behalf of each City Commissioner to use for their specifically requested city events and programs and any associated expenses; and

WHEREAS, the Vice Mayor Barry Moss is hosting a town hall meeting on February 13, 2020 at the Skolnick Center; and

WHEREAS, Vice Mayor Barry Moss wishes to support the above event by sponsoring a not to exceed amount of \$500.00 of his apportioned funds to cover costs for refreshments and necessary logistics; and

WHEREAS, Vice Mayor Barry Moss is hosting an event featuring music, refreshments and health screening activities for residents located on the Esplanade in Palm Aire on February 23, 2020; and

WHEREAS, Vice Mayor Barry Moss wishes to support the above event by sponsoring a not to exceed amount of \$4,000.00 of his apportioned funds to cover costs for talent, sound, refreshment tents, marketing materials, any necessary permits and other incidentals; and

WHEREAS, the City Commission has determined that the best interests of the public will be served by providing funding, on a cost reimbursement basis, for these events, which are open to all City residents; now, therefore,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That it is the determination of the City Commission of the City of Pompano Beach, Florida, that the town hall meeting and the Music on the Esplanade events, supported by Vice-Mayor Moss, serve a public purpose.

SECTION 2. That the City approves and authorizes the appropriation of a not to exceed amount of Five Hundred Dollars (\$500.00), from the designated funds for such events for Vice Mayor Barry Moss, sponsor the town hall meeting to be held on February 13, 2020 and the appropriation of a not to exceed amount of Four Thousand Dollars (\$4,000.00) from the designated funds for such events for Vice Mayor Barry Moss to sponsor the event featuring music, refreshments and health screenings to be held on February 23, 2020, and that such funds shall be disbursed on a reimbursement basis following presentation of verified receipts to the City Manager.

SECTION 3. This Resolution shall become effective upon passage.
