Good morning,

During the review prior to the first reading of the City Commission for this contract, there were two issues identified. The first was by our Risk Manager, the language in Exhibit B as it relates to the Certificate of Insurance requirements was outside industry standard, and after further review we lowered the requirements of the General Liability to be more in line with industry standards. Second, a discrepancy between Articles 3 and 5 was discovered. Where the contract's term is for 5 years, but individual projects will be shorter, Article 5 lost meaning. We added language to clarify when liquidated damages would apply.

Please review the changes and if acceptable respond via email no later than tomorrow at noon. We will make the changes before the second reading which need to be finalized for distribution to our commissioners by tomorrow. If you have any concerns please email me back.
