### Special Virtual City Commission/ EMS Taxing District Meeting

### **CALL TO ORDER**

The Honorable Rex Hardin, Mayor called the Special Virtual City Commission meeting to order at 5:15 p.m.

### **APPROVAL OF AGENDA**

A motion was made by Vice Mayor Moss, seconded by Commissioner Perkins, that the AGENDA be APPROVED. The motion carried by a unanimous voice vote.

#### A. PUBLIC HEARING

### **PRESENTATION**

Mayor Hardin introduced the item on the agenda, a staff presentation of the proposed millage rates and proposed budgets of the City of Pompano Beach for Fiscal Year 2020-2021. He then turned the floor over to City Manager Greg Harrison.

Mr. Harrison turned the meeting over to Erjeta Diamanti, Budget Manager, to begin the presentation.

Ms. Diamanti stated that this is the first virtual public budget hearing to adopt the recommended millage rates and proposed budgets for Fiscal Year (FY) 2020-2021, as well as to adopt the final Fire Assessment

Resolution. Also, there is another item involving the Human Resources Department related to personnel reclassification. She then explained the intent of the presentation, which was to provide the Commission with a recap of the City's budget process and the City's FY 2021 recommended budget for all funds.

Ms. Diamanti provided the outline for the presentation, which consists of the Annual Budget Process Timeline, Policy Recommendations, FY 2021 Recommended Budget for All Funds, FY 2021 Recommended General Fund Budget, FY 2021 Recommended Fire Assessment Fees, FY 2021 Recommended Millage Rates as well as the next steps in the budget process. Attached as Exhibit 1 is a copy of the presentation in its entirety that provides a more detailed breakdown of the FY 2021 recommended budget.

In sum, Ms. Diamanti highlighted the recommendations for the FY 2021, which are as follows:

- There are no proposed changes to the Fire Assessment Fees for FY 2021. The rate for residential will remain at \$220. When compared to FY 2020 adopted fire rates of the 26 municipalities in Broward County, the City ranked the 8th lowest. However, it is important to note that the new FY 2021 rates for the municipalities are not yet available.
- The General Fund supports ad-valorem revenues of approximately 100% of the Ocean Rescue Division (\$2.3M) and 38% of the EMS Budget (\$7.5M).
- There will be no changes to the 2021 recommended operating millage rate. The operating millage rate will remain at 5.1875.
- FY 2021 EMS millage rate will be capped at .5000.
- The GO Bond debt service experienced a decrease. The rate is 0.4194.

Overall, when compared to the FY 2020 adopted aggregate millage rate of 6.1326, the FY 2021 recommended aggregate millage rate of 6.1069 decreased by -0.42%. Also, in comparison with the 31 municipalities in Broward County, the City is ranked the 11th lowest. Again, the comparison with the cities is based on the 2020 adopted millage rates.

Ms. Diamanti went on to explain how the evaluations and proposed rates impact Pompano Beach residents' tax bill. An average homestead property with a value of \$200,000 will experience a decrease of \$4; however, a non-homesteaded property with the same value will see a reduction of \$6.

Lastly, Ms. Diamanti stated that today is the 1st Budget Hearing and September 21st is the date for the final public budget hearing when the City adopts the final millage rates and budget along with the five-year Capital Improvement Plan.

Mayor Hardin asked if there were any public comments on the item, to which Sandra King, Public Communication Director replied no.

### **B CONSIDERATIONS**

1. 20-501 Adoption of tentative millage rate for the City of Pompano Beach for Fiscal Year 2020-2021 reflecting a General Fund operating millage of 5.1875 and a voted Debt Service millage of 0.4194 for a total millage of 5.6069. The City's proposed aggregate millage rate of 5.6875 represents a 4.12% increase in property taxes when compared to the aggregate rolled-back millage rate of 5.4626. This increase in property taxes is due to the increase in the City's assessed valuation of taxable property on the 2020 Tax Roll.

Ms. Diamanti stated the EMS budget was removed from the total number referenced in this item, because the EMS budget will be adopted under the EMS District.

Comr. McMahon said staff did a great job. With the City ranked as the 11th lowest in taxes within the County while continuing to provide the same services, adding a new patrol district and freezing 11 positions were things that had to be done. Also, he extended kudos to staff for keeping the taxes the same and even lowering them during the present situation. He recalled during the budget hearings the Commission members were all on the same page to make sure a burden was not being placed on the residents.

Mayor Hardin stated he, as well as, the other commissioners echoed Comr. McMahon's sentiments and he thanked staff for their hard work on this process.





## FY 2021 RECOMMENDED GENERAL FUND BUDGET BY FUNCTION




## POMPANO BEACH PROPERTY VALUATION (2015-2020 TAX ROLLYEAR)






