AMENDING SECTION **"INSTITUTIONAL: OTHER INSTITUTIONAL** USES," TO **MODIFY** PERMITTED USES IN THE I-1X DISTRICT TO PERMIT LODGES OR CLUB USES AND AMENDING APPENDIX A TO MODIFY THE TABLE TO CONFORM TO CHANGES IN THE ZONING CODE; PROVIDING FOR SEVERABILITY; **PROVIDING AN EFFECTIVE DATE.**
