I write regarding the above referenced Ordinance on behalf of T-Mobile South, LLC. ("T-Mobile"). Subsequent to First Reading, T-Mobile along with its Industry colleagues have had discussions with your City Attorney Mark Berman in a mutual effort to draft language that respects state and federal laws, technical feasibility as well as local management of the City's public rights-of-way and aesthetic concerns.

As a result of very productive dialogue between the Industry and Mr. Berman, the vast majority of our remaining concerns have been addressed either satisfactorily or in a manner that we reasonably expect will allow deployment of small wireless facilities. Although we do not anticipate implementation issues at this time, we appreciate Mr. Berman's and the City's open mind and open door to possible future discussions and/or implementation "tweaks" as may be necessary and appropriate in the event material obstacle(s) arise to deployment of small wireless facilities.

In closing, on behalf of T-Mobile and myself, we extend our sincere appreciation to your City Attorney Mark Berman, City Engineer, John Sfiropoulos and City Manager, Greg Harrison, for their time, professional manner and consideration of our input. It is truly appreciated.
