**DECLARATION OF UNITY OF TITLE**

KNOW ALL MEN BY THESE PRESENTS, that as of the 15th day of September, 2016, pursuant to the applicable ordinances of the City of Pompano Beach pertaining to the issuance of building permits and regulating building construction, the undersigned, JMPM Limited Partnership, a Florida limited partnership, being the fee owner of following described real property lying, being and situate in the City of Pompano Beach, County of Broward, and State of Florida, to-wit:

Lots 9, 10 and 11, in Block 11 of AMENDED PLAT OF FAIRVIEW, according to the Plat thereof, as recorded in Plat Book 10, Page 25 of the Public Records of Broward County, Florida, a/k/a 941 SW 8<sup>th</sup> Street, Pompano Beach, FL 33069.

Does hereby make the following declarations of conditions, limitations and restrictions on said lands;

1. The aforesaid plot, parcel or combinations of separate lots be and the same are hereby established and declared to be unified as an indivisible building site.
2. This Declaration of Unity of Title shall constitute a covenant running with the land, as provided by law, and shall be binding upon the undersigned, its successors and assigns, and all parties claiming thereunder and no portion shall be sold, assigned, transferred, conveyed or devised separately except in its entirety as one plot or parcel until such time as the same may be released in writing under the order of the Development Services Director of the City of Pompano Beach.
3. The undersigned does further agree that this instrument shall be filed for recordation among the Public Records of Broward County, Florida.
