City Commission Meeting

CALL TO ORDER

APPROVAL OF MINUTES

[23-724](#) City Commission Budget Workshop Minutes of July 18, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Sigerson-Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

23-723 Regular City Commission Meeting Minutes of July 25, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Sigerson-Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

APPROVAL OF AGENDA

Mayor Hardin announced Item 4 under Consent Agenda will be postponed until the September 26, 2023 City Commission meeting.

A motion was made by Vice Mayor McGee, seconded by Commissioner Sigerson-Eaton, that the Agenda be APPROVED AS AMENDED. The motion carried by a unanimous voice vote.

CONSENT AGENDA DISCUSSION

The Commission may pull items from the Consent Agenda. During Audience to be Heard, a person may speak on any item on the Consent Agenda, which has not been pulled.

Mayor Hardin announced that Items 1, 2 and 6 would be pulled for City Commission discussion.

A. SPECIAL PRESENTATION**23-736** **Legislative Update From Senator Jason Pizzo**

Senator Jason Pizzo stated the incoming Senate President and Division of Emergency Management Kevin Guthrie will be visiting the District to discuss emergency operations from a regional perspective. He noted they have secured \$1.1M for septic sewer conversion for Pompano Beach. He added that each Commissioner should have received a request for 1-on-1 meeting in their email. Senator Pizzo added that he recently completed a ride-a-long with Lieutenant Ulvang through Pompano Beach. He confirmed that the Commission have his cell phone number and encouraged each commissioner to contact him with any questions they may have. Lastly, he noted that he was recently elected to serve as Chairperson on the Broward County Delegation and he will be the incoming Senate Democratic Leader in the Florida Senate beginning next year.

The Special Presentation was READ AND PRESENTED INTO THE RECORD.

23-509 **Property Value Update from Broward County Property Appraiser**

Marty Kiar, Broward County Property Appraiser, thanked the city staff for their work with his office. He provided a background on his office's function. He spoke about the increase of property values including new development in the County. He noted there has been a 17%

increase in market value and 12% increase in taxable value. There has been \$136M in new construction added to the tax roll. He summarized the current exemptions, including the significance of the long-term senior exemption. He noted the average sale price of a single-family home is \$700,257 and average taxable value is \$275,000. He said the average sale price of a condominium parcel is \$345,000 and the average taxable value is \$210,000. He explained title fraud and the Owner Alert program. He provided examples of local property fraud.

Vice Mayor McGee asked if the Property Appraiser's Office is looking at ways to help the increases of insurance rates, construction costs, inflation, etc. for condominiums.

Mr. Kiar acknowledged how expensive it is for seniors living in Broward County. He said property values are skyrocketing and explained how they determine the value of property. He noted they also work hard to get information out to seniors for tax-saving exemptions. He noted they are limited under Florida law in how they value properties.

Comr. Moss asked if the senior exemptions are based on income. Mr. Kiar replied yes and provided further explanation on qualification.

Comr. Moss asked about protecting investment properties through the Owner Alert program. Mr. Kiar responded it is possible to register but proof of ownership is required.

The Special Presentation was READ AND PRESENTED INTO THE RECORD.

B. PROCLAMATIONS

23-696 Suicide Prevention Month

Mayor Hardin proclaimed the month of September as Suicide Prevention Month in the City of Pompano Beach. Beth Nativ, member of the League of Women Voters came forth to accept the proclamation on behalf of the League.

23-729 Emergency Preparedness Month Proclaimed

Mayor Hardin proclaimed the month of September as Emergency Preparedness Month in the City of Pompano Beach. Kimberly Cristiano, Pompano Beach Fire Rescue Emergency Manager, and Krystal Aaron, Emergency Management Coordinator, accepted the proclamation. Ms. Cristiano announced the upcoming CERT class on October 4th.

RECORD.**C. AUDIENCE TO BE HEARD**

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

Rodrick Phillips, 2620 NW 10th St., Pompano Beach, presented each Commissioner, City Manager Harrison, and BSO with a Certificate of Appreciation from Exit 36 New Life Group. He said they are trying to help with addiction, homelessness, and those suffering with mental illness in the City.

Ed Phillips, 384 NW 19th St., Pompano Beach, said he pays taxes and he believes residents should be given a certain level of communication. He mentioned the Kendall Lakes Homeowner's Association and said he is thankful for the drainage program, but he is unhappy with the communication as it pertains to the residents within the neighborhood. He referenced a document that was distributed to the dais. He said his District Commissioner should have informed the residents about the work on the street and stated it needs to be more than a day's notice. He said he received a knock on his door at 7:00 A.M. to move his car.

Mayor Hardin said he was notified of Mr. Phillips complaints, and he forwarded them immediately to the City Manager. City Manager Harrison connected with the City Engineering Department for more information. He stated the contractor claimed they went door to door to speak with people or left written communication at each door.

Mr. Phillips said he represents the complaints of the residents on 19th Street. He reiterated his only notice was a knock on his door the morning of the work.

Comr. Fournier said Lion's Park went through a similar challenge with communication. She suggested utilizing social media for announcements of larger projects.

Comr. Perkins said she pulled Item 6 to further discuss Kendall Lakes. Mayor Hardin said she should wait until the item is called under the Consent Agenda.

Vice Mayor McGee suggested working with IT to see if there is an alternative in order to provide updates to specific areas or neighborhoods that people could opt into.

Rosie Ward & Ollie Singletary, Pompano Beach, said they were homeless and got kicked out their apartment because they could not afford the rent once it was raised. They thanked BSO and a City staff member for their help. Mr. Singletary said they were living on bad street in Collier City and the City helped them get an apartment on 501 MLK Boulevard. He said they are grateful to be citizens of Pompano Beach and said the programs do work.

Mayor Hardin said he was glad that they were able to be helped and living in a place that is safe and secure. He stated the City staff member they are referring to is Cassandra Rhett.

Comr. Perkins expressed concern about the availability of affordable housing in her district. Developers are

building townhomes and apartments at market rate prices. She said she knows people who have vouchers who still cannot find affordable housing.

Mayor Hardin agreed there is also a need for affordable housing and they can always use more. He provided examples of affordable housing development projects.

Joe Naegele, 430 SE 8th Ave., Pompano Beach, said he spoke a year ago about a motel next door to him. He said the City classifies it as a short-term rental. He said the place has \$65,000 in fines as of May and wondered why the fines were reduced \$5,270. He asked why.

Mayor Hardin said he does not have an answer to that question; however, the City Attorney's Office and Mr. Sotolongo, the City's Code Compliance Director would both have access to the information.

Mr. Naegele said the property continues to rent and trash continues to be an issue. He said the fine reduction is a slap on the hand and many residents on 8th and 9th Avenue have had enough. He spoke about a new \$13,000 fine issued in April and it has been over 90 days. He said by Florida Statute, after 90 days, a foreclosure process can be initiated by the Special Magistrate. He asked for a foreclosure proceeding to be initiated against the property.

Mayor Hardin said he encourages the City Attorney's Office to pursue foreclosure proceedings when appropriate. He suggested Mr. Naegele connect with City Attorney Berman or Mr. Sotolongo.

City Manager Harrison clarified that the Commission does not have authority over the fines. The fines are set by the Magistrate during the hearing. He recommended Mr. Naegele testify in front of the Magistrate.

Mayor Hardin reiterated he connect with Mr. Sotolongo. He acknowledged it is a vexing problem throughout the City.

Comr. Fournier said she has spent a lot of time speaking with Mr. Naegele over the last 21 months. She asked about a claw back option if fines were reduced by the Magistrate but then the violation occurs again.

City Attorney Berman stated there are provisions for repeat violators with heftier fines and penalties. He said he will make the City's position clear for repeat violator cases.

Jordon Brown, 100 NE 10th St., Pompano Beach, commented on the helicopter crash incident in August. He said they were told to leave the premises due to the crash. He said the City of Pompano does not have an emergency plan in order for incidents that are not natural. He stated no help was offered and he was very surprised to learn there is one City employee in the Social Services Department. He noted no one from the City reached out to them. He asked what the City can do better to help the residents.

Mayor Hardin replied that City Manager Harrison serves as the liaison to the Red Cross on issues such as this.

Mr. Brown confirmed the Red Cross was involved but some of the residents are still homeless and living in hotels. He said the Red Cross has offered some assistance, but it is not good enough and they need tangible

help.

Mayor Hardin asked Mr. Brown to connect with City Manager Harrison. He said the building is condemned but there are other places to rent.

Comr. Perkins said they had a similar situation a few months ago when the 7th Avenue apartments burned down. She said those residents also received little to no help and she was disappointed with the Red Cross and the City. She recommended better plans for emergencies.

Mr. Brown said the Red Cross was not notified of the incident. A Red Cross employee said there was no formal invitation for them to come and she informed them after seeing the incident on the television.

Mayor Hardin asked City Manager Harrison to find out how the Red Cross provides support. He asked City Manager Harrison to connect with Mr. Brown about available resources.

City Manager Harrison asked Mr. Brown to speak to Chief Brocato at the back of the room.

Comr. Sigerson-Eaton spoke about the lack of information and communication during emergencies. She spoke about Code Red and recommended identifying a better way to inform surrounding communities during emergencies. She provided an example at the elementary school.

Mayor Hardin said the priority is for the first responders to take care of the emergency. He agreed that they can always try to do better.

Brandi Monvel, 100 NE 10th St., Pompano Beach, said Mr. Brown is her brother and she is just piggybacking in regard to the incident. She said they lost everything and said no one reached out to them for assistance or housing. She noted that Red Cross gave them \$600 but it does not go far. She said they were failed and do not know what to do about affordable housing. She asked for help in identifying assistance.

Mayor Hardin reiterated they speak to Chief Brocato.

Comr. Perkins asked for the apartment address. Ms. Monvel said 100 NE 10th St., Unit 8.

Alex Boardman, 2600 NE 19th St., Pompano Beach, spoke about speed control on his street. He thanked Vice Mayor McGee for forwarding his request to the City Manager but noted it was denied based on a speed review preformed in July. He said his daughter's best friend was almost hit by a car and he believes they can do something about it. He asked City Manager Harrison to reconsider the assessment.

Mayor Hardin said it should not be a problem to do another traffic count. He asked Mr. Boardman to recommend a time for another study.

Comr. Fournier stated she understands the struggle and believes the City needs to listen to people more and trust their perspective as parents. She said they need to address the ongoing challenge between the City and parents.

Vice Mayor McGee said Mr. Boardman is not the only neighbor who expressed this concern. She stated she was shocked that the City only recorded data for one day, therefore she recommended multiple days, including a weekend to get a better sense of the neighborhoods. She asked Mr. Boardman to help the City identify better days to measure.

Comr. Moss said he receives this complaint weekly in Palm Aire. He said they cannot put traffic calming measures everywhere they are requested and said traffic backups would be worse. The County determines traffic calming based on standards. He asked who determines placement of speed bumps.

City Manager Harrison said the speed bump locations are made by the City Engineer and Police Chief, but they use the County criteria.

Comr. Sigerson-Eaton said it is difficult, especially in District 2. She said they need to follow the County's criteria, but they previously discussed lowering the speed limit. City Manager Harrison said he does not recall the conversation, but he would be happy to look into it.

Comr. Moss said lowering speed limits has had very little effect in Palm Aire.

Comr. Fournier said they need to make strategic decisions to make traffic work within the City and out of the neighborhoods.

Vice Mayor McGee stated they could look at other options, including roundabouts. She noted that enforcement is another component.

Pat Anderson, 2650 NE 24th St., Pompano Beach, asked for the records of the "smash" that happened on May 5, 2017. She said it has been six years of identity theft. She read from a timeline document. She spoke about an art scam. She said the real estate world is watching. She distributed copies to the dais.

Mary Phillips, 3854 NW 19th St., Pompano Beach, said they should reevaluate the criteria for speed humps because neighborhoods change. She announced upcoming programs. She thanked Comr. Sigerson-Eaton for her support of Wellness Fest. She asked for ongoing donations for their programs. She noted she will be making a recommendation to use funding for sustainable improvements. She said the insurance rates are high because people need new roofs and updated electrical boxes.

Saracha Peterson, 4354 NW 9th Ave., Pompano Beach, played a video showing the process to produce the Pompano Beach Soundtrack. She noted they have selected the final six artists and are preparing to go into the studio.

Nancy Olsen was called to speak, but was not present.

Comr. Perkins asked if it includes the light pole installation. Mr. Beaudreau answered it does.

Comr. Perkins said she receives complaints about the design on the light poles on MLK Boulevard. She will provide Mr. Beaudreau with pictures of the design from last year.

Mayor Hardin opened the floor for public input. No one came forth to speak on the item. Therefore, the Mayor closed public input and invited further Commission discussion on the item.

Vice Mayor McGee asked to brighten up the center median on Atlantic Boulevard. Mr. Beaudreau replied they will look into it.

He reviewed a map of Pompano Beach with B-2 zoning and said the Zoning Board of Appeals (ZBA) found that the applicant did not demonstrate competent and substantial evidence satisfying the granting of an application. The application was denied at the April hearing. The proposed text amendment was presented to the Planning and Zoning Board in July and recommended approval by a 5-2 vote.

Mr. Rahil Sanghvi, 8300 NW 123rd St., Whiteland Park, introduced himself as the applicant. He began his presentation by reviewing the following: B2 versus B3 Visitor Accommodation Uses; Condo Hotel defined as per Sec. 155.4225; Hotel as defined per Sec. 155.4225; B2 versus B3 Intensity and Dimensional Standards; and Comprehensive Plan.

Mayor Hardin opened public comment.

Michael Skversky, 1630 SW 5th Ave., Pompano Beach, referred to the ad of the Ordinance from the Sun Sentinel and asked if it should have included an address. He asked if the developer wants to put up a 105-foot building.

Mayor Hardin clarified that this item is for a text amendment and that B2 zoning permits 105 feet throughout the City.

Mr. Skversky said it does not make sense to put anything there.

Mayor Hardin closed public input and invited further Commission discussion on the item.

Comr. Fournier expressed concern about the project and the city-wide implications. She said she heard the residents' concerns about the proposed hotel on McNab Road, that was subsequently denied. She believes the code is correct in this instance.

Vice Mayor McGee stated B2 already allows the condo hotel model. She wondered if the lack of hotels adds to the demand of short-term rentals. She said they do not have many hotels. She agrees with Comr. Sigerson-Eaton that there is even a designation.

Mayor Hardin asked Mr. Keester-O'Mills if staff supports the text amendment. Mr. Keester-O'Mills replied yes.

Mayor Hardin inquired why hotels were not originally permitted in B2. Mr. Keester-O'Mills responded that he does not know.

Mayor Hardin acknowledged that he is aware that the applicant is proposing the text amendment so he can do his project. He spoke about another option in B3 with a restrictive covenant.

Mayor Hardin asked if staff took a position at the ZBA meeting. Mr. Keester-O'Mills replied that staff does not take a position on ZBA items.

Mayor Hardin disclosed he received a few emails in opposition of the item.

Mayor Hardin asked for clarification if this would open the option to have a hotel in B2 residential. Mr. Keester-O'Mills replied yes and noted the residential project on Cypress Road. He further explained the code provision.

Comr. Moss asked about why the ZBA's rationale was not included in the backup. Mr. Keester-O'Mills responded because it was a different application.

Comr. Moss asked about the plans for the hotel. Mr. Keester-O'Mills replied that he has no answer to what could go on this property. He invited the applicant to share his plans if he wants to address Comr. Moss's inquiry.

Mayor Hardin reiterated that the text amendment applies city-wide.

Mr. Sanghvi stated he plans to develop 70-72 units on the site. He said the building would be 4-5 stories, which is half of the allowable height. He suggested there is an inconsistency in the code and argued there is no

difference between a condo hotel and a regular hotel. He said he is not trying to backdoor a project and noted he disagreed with the ZBA's traffic concerns.

Comr. Moss said a hotel would be welcomed in his district.

Comr. Fournier said a condo hotel and hotel are not exactly the same.

Comr. Sigerson-Eaton referenced the Pompano Beach zoning map and said when she looks at the surrounding areas, the conditions are the same.

Upon the effective date of the ordinance, the Mayor and Commission should appoint the At-Large Member and two alternate members. He noted the alternate terms have expired and need to be re-appointed. The alternates would be in place until the municipal election of 2024. Two alternate members' terms will run concurrently as three-year terms and expire following induction of officials from the municipal election of 2024. Board members whose terms were set to expire in 2024, prior to the next municipal election, will be extended until the induction of officials from that election. The terms of three Board members that are set to expire in 2025, shall be reduced by several months to expire as of the induction of City officials from the municipal election of 2024. Finally, Mr. Berman noted that he included a provision whereby the At-Large Member, Regular Members, and Alternate Members shall continue to serve until their successors are appointed.
