APPROVAL OF MINUTES

23-765 Regular City Commission Meeting Minutes of September 12, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Sigerson-Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

APPROVAL OF AGENDA

Mayor Hardin announced Item 8 under the Consent Agenda will be postponed until the October 10, 2023 City Commission meeting.

Mayor Hardin announced that Item 3, 4, 5 and 6 would be pulled for City Commission discussion.

A. PROCLAMATION

23-753 Proclamation for Volunteer Recognition

Mayor Rex Hardin read a proclamation recognizing CERT Member Fred Balestriero for his 25 years of volunteer services to the Pompano Beach Community Emergency Response Team. Mr. Balestriero accepted the proclamation.

The Proclamation was READ AND PRESENTED INTO THE RECORD.

B. PRESENTATION

23-764 Recommended 2023-2025 Strategic Plan Presentation

Ernesto Reyes, Strategic Plan Manager, introduced the item and provided a brief background. Mr. Doug Serrano of Quiet Excellence, LLC, introduced himself to the City Commission. He discussed the following in the presentation: Mission, Vision, and Values; "SMARTER" Strategic Planning; and Objectives.

Mayor Hardin thanked Mr. Serrano for the framework and plan.

Mr. Serrano stated the Pompano Beach City staff were the best he has ever worked with.

The Presentation was READ AND PRESENTED INTO THE RECORD.

C. AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

Pastor Tim Griffin, 20871 NW 1st Street, Pompano Beach, was accompanied by Pastor Harold Westley, Ernestine Martin of The Worldwide Christian Center, Pastor Ron Harper of Kingdom Ministries and Pastor Miquel Cruz. Pastor Griffin spoke about the PPP group and said they are here to educate, inspire, and rebuild the community. Their group was established in March 2023 and are meeting twice a month with BSO. Pastor Harper explained the group's mission, stating they are there to bridge the gap between the police, public figures, and the community. He said they have partners who assist with housing, rent, and food. Pastor Cruz recognized Captain Stallings and their partnership with BSO.

Mayor Hardin commended the pastors for establishing the PPP group and expressed appreciation for their efforts in helping to make the community a better place to live.

Vice Mayor McGee asked how others can get involved. Pastor Griffin responded by providing the Group's Facebook page and phone number - Facebook address: @ppp & Phone number: (305)494-5081.

Pat Russell Anderson, Pompano Beach, stated that on behalf of the National Wildlife Federation, Broward County Property Appraiser's Office and Army Corp. of Engineers, she would like to create an Exchange Club Park, west of the pink church. She displayed a rendering of the proposed park and said the infrastructure at the church needs to be reconstructed. She noted the house next to hers is now in Lighthouse Point. She shared her desire for the widening of the entrance to the Hillsboro Inlet. She also offered to help to reclaim submerged land lost during past dredging efforts. Lastly, Ms. Anderson distributed materials to the City Commission for review.

Karen Turner, 1969 NW 5th Way, Pompano Beach, spoke about a complaint regarding the Code Compliance Division. She stated that there was a huge tree that fell in her yard, and she was later issued a citation for the tree. She said the Code Compliance Division did not want to hear about her exception and asked her to correct the issue even though she has an economic hardship. Mayor Hardin asked Ms. Turner to connect with City Manager Harrison to address the matter.

Tundra King, 124 NW 15th St., Pompano Beach, commented about a meeting last night regarding Pompano Terrace. She said one of the BSO lieutenants at the meeting was unprofessional. She noted it is not the first time the officer has been condescending and stated that Comr. Perkins witnessed the incident and handled the matter in a professional manner. She stated the lieutenant did apologize but they need to take a closer look since there are already trust issues.

Comr. Perkins stated the meeting was about signage for junk cars. She noted Pastor Cruz and Code Compliance Director Mario Sotolongo picked up some of the signs this morning.

Vicente Thrower, 1890 NW 6th Avenue, Pompano Beach, asked if the City Commission received an invite to the Community Meeting held by a State Representative. He recommended the Commission to watch a video on Channel 4 about schools in Pompano Beach. He said the Commission has a fiduciary responsibility to hold the Broward County School Board responsible for the conditions of the schools in the city. He spoke about the conditions of two schools and felt the matter is not being taken seriously. He urged the Commission to meet with the School Board to discuss the matter.

Mayor Hardin expressed appreciation for Mr. Thrower's comments regarding the school system. He, along with

members of the School Board met at Markham Elementary, and noticed the conditions are not what they should be. Nevertheless, they are working with the School Board to carry forth with the desired improvements.

Jocelyn Jackson, Pompano Beach, asked about the cultural grant funding for the construction of the Botanical Gardens. Mayor Hardin replied it is under the Cultural Affairs Department. Ms. Jackson expressed concern about how the word "cultural" is identified.

Next, she stated no one can prevent her from showing up somewhere if she is not breaking a law. She congratulated Miriam Carrillo for placing African Americans in homes and said it is embarrassing that she is under attack. She asked Major Adkins to contact her directly with any issues.

Sarahca Peterson, 4354 NW 9th Avenue, Pompano Beach, asked why the commissioners' seats switched. Mayor Hardin said they are seated in alphabetical order, and then Vice Mayor and Mayor.

Ed Phillips, 384 SW 19th St., Pompano Beach spoke about the City's homeless issue and said they need to find a way to move people along. He said it is difficult for him to go into his workplace in the mornings when there are homeless people in front of it. He advised the City to identify people who want resources.

Mayor Hardin stated they need cooperation with landowners and property owners to participate in the No Trespassing Program. BSO cannot simply go to a site and move people along.

Comr. Perkins said she agrees with the previous recommendation to form a Homeless Advisory Board. Mayor Hardin replied that the City Manager was researching what is done in other cities.

Allison Aurilio, 2481 NE 12th Terrace, Pompano Beach, spoke about the bright streetlights in her neighborhood. She said they are so bright that her privacy has been taken away. She noted that the lights shine into her backyard and are equivalent to stadium lights. Although, the City added shields to reduce the lighting, it made no difference. She said she feels unsafe with the street lights.

Mayor Hardin asked City Manager Harrison to have Mr. Danovich connect with Ms. Aurilio to determine if a different type of shield can be used to address the lighting issue.

Comr. Sigerson-Eaton acknowledged that removing the bright lights has been a process and stated it has been taking longer than they anticipated. She provided her contact information to Ms. Aurilio.

Comr. Perkins said she pulled the item for a resident, Ed Phillips.

Ed Phillips, 384 NW 19th St., Pompano Beach, spoke about the need for input from African Americans regarding the Strategic Plan. He said he is not in support of Pompano Beach having a charter school due to double taxation concerns. He advised the City needs to define affordable housing, stating that the youth are returning home because they cannot afford to move into a place of their own. In closing, Mr. Phillips said corporations are siphoning off benefits that need to go to schools and nonprofits.

Comr. Perkins agreed with Mr. Phillips, stating the City needs to consider the input from African Americans more as the City grows.

Comr. Fournier said she had a similar reaction about diversity when she reviewed the Strategic Plan presentation, noting it does not reflect Pompano Beach.

Vice Mayor McGee said the next steps should be how to better support the City population as a whole.

Comr. Perkins encouraged her fellow commissioners to attend the track and field events.

Joe Ballard, 1861 NW 7th Terrace, Pompano Beach said the issue from July has been resolved. He briefly commented on his youth program, stating the youngest group are 5 years old. He also highlighted the benefits of the program and noted they are focused on the track at this point. Comr. Perkins said there are grants for track programs.

Jocelyn Jackson, Pompano Beach, thanked Mr. Beaudreau for working with her community. She said she is excited to attend the track events. Also, she supports the pursuit for grant funding for the multiplex. Lastly, she urged everyone to work together as a team.

Comr. Fournier expressed concern about NE 10th Street. She asked if the spend tables and roundabouts were removed from the plan. John Sfiropoulos, City Engineer, responded they were eliminated because the stretch was not conducive to the speed tables and roundabouts. He said converting the striped medians to raised curbed islands, would be the solution for traffic calming.

Comr. Fournier asked about a traffic count for the subject street. Mr. Sfiropoulos replied that Major Adkins requested one from the County, but it has not been done recently. Comr. Fournier requested to see the data when it is available. Mr. Sfiropoulos noted it is a major City road.

Michael Skversky, 1630 SW 5th Avenue, Pompano Beach, said the traffic in the last year may have doubled and will get worse in November through January. He asked for clarification about traffic calming. Mr. Sfiropoulos responded stating it is not traffic calming in the traditional sense, he said they are proposing to put curbed, landscaped medians. Mr. Skversky is opposed to the proposed traffic calming approach but he requested not to put in speed bumps.

Mayor Hardin stated it is designed to slow traffic down and beautify the area.

Mr. Sfiropoulos said the lines are confusing and should be fixed.

David Hall, 290 SE 8th Court, Pompano Beach, commented on the previous item, stating it should not be difficult to get power in the median that Vice Mayor McGee requested. With regard to the proposed item, he said enforcement of speeding is the best thing to do.

Comr. Sigerson-Eaton agreed with the recommendation to drop conduit to get power into the medians. She said the Dixie Highway and 10th Street stoplight is an issue because it seems to be shorter and needs better

coordination. Mr. Sfiropoulos stated that he will try to work with the County on signal timing.

Vice Mayor McGee asked about the construction timeline. Mr. Sfiropoulos replied the program is 8 years out.

Mayor Hardin opened the floor for public input.

Mike Skversky, 1630 SW 5th Avenue, Pompano Beach, stated this project will open up a can of worms. He said the project does not make any sense and does not fit in the area.

David Hall, 290 SE 8th Court, Pompano Beach, spoke in favor of the item. He said it will probably be a down brand property, however it will not interfere with traffic. He believes the word, "motel" is just a scare tactic.

Bryan Zasvanage, 61 SE 11th Street, Pompano Bach, spoke in opposition of the item, stating it is a bad idea. He commented about the zoning and stating it feels like a backdoor tactic. He said it will inundate neighborhoods with more building and traffic.

Sarahca Peterson, 4354 NW 9th Avenue, Pompano Beach, inquired about B-2 and B-3 zoning. Mr. Keester-O'Mills explained the difference and similarities. Ms. Peterson spoke about hotels versus condo hotels and said the City needs more affordable hotels.

Sean Spire, 281 NE 8th Court, Pompano Beach, spoke in opposition of the item. He commented on the different zoning areas, increased crime, traffic, property values, safety, and the environmental impact. He said they need to prioritize small businesses and work on decreasing crime.

Carol Foster, 271 SE 12th Street, Pompano Beach, spoke in opposition of the item, stating that the proposed site is located in a residential area. She said the City needs to protect their neighborhoods.

Mayor closed public input and invited further Commission discussion on the item.

Mayor Hardin asked how many vacant parcels of B-2 zoned property are available. Mr. Keester-O'Mills replied he does not have that information. Mayor Hardin listed some vacant parcels he is aware of.

Mayor Hardin asked if there are single-family residences directly north of McNab Road. Mr. Keester-O'Mills replied that he does not know.

Mayor Hardin asked where hotels are allowed in residential areas. Mr. Keester-O'Mills said they are not a permitted use by right and are all special exceptions in residential districts.

Comr. Moss commented on a letter of objection in the backup from the CRA. He said he spoke with Mr. Tran who convinced him that this item is not a good idea. Mr. Tran said a Special Exception is a better way to go and he invited Mr. Tran to share the CRA's position.

Nguyen Tran, CRA Director, acknowledged the letter of non-support from the CRA. He said this is not about use and hotel use, rather this is a text amendment and he spoke about Special Exception as an option. He also expressed concern about approving the permitted use by right and displayed the Northwest Zoning district map and described the areas where he has concern.

Comr. Moss said that the Collier's City residents want single-family homes. He noted that he has nothing against the hotel, but agreed it is not a good idea to make it a use by right. He said he will reverse his vote and vote no on

the item.

Comr. Fournier said she voted no at the last hearing. She has concerns about broad text amendments that have unintended consequences in the future. She said she appreciates Mr. Tran's letter and believes they should not undermine the Zoning Board of Appeals (ZBA) and its process. In sum, she does not support this broad policy amendment.

Vice Mayor McGee agreed that a specification in the zoning code to differentiate a hotel from a motel is necessary. She agreed that the condo hotel can go bad as well. She currently lives across the street from the Hilton Hotel and indicated crime has not increased. Moreover, Vice Mayor McGee asked if the Special Exception could be brought to the City Commission. City Attorney Berman replied a motion for rehearing could be filed by the Applicant or the Applicant can appeal to the Circuit Court.

Comr. Sigerson-Eaton agreed that a distinction is needed between hotel and motel. She said a condo hotel and hotel is distinct but not different. She spoke about B-2 and B-3 zoning.

Mayor Hardin asked Mr. Tran why the City has not proposed to define hotel versus motel. Mr. Tran replied this is not a text amendment and should be a rezoning request. He reiterated the CRA's opposition to the text amendment.

Mayor Hardin asked Mr. Keester-O'Mills the same question. Mr. Keester-O'Mills said they have never had a problem or the need to investigate the matter.

Mayor Hardin asked staff to begin work on defining hotels vs. motels with parameters.

Mayor Hardin asked why is the CRA in opposition to item, but City staff supports it. Mr. Tran said the staff report does not include a recommendation either way. Mayor Hardin noted he asked at the first reading if it was supported by staff. Mr. Keester-O'Mills said that Mr. Tran is looking at the item from the CRA's perspective and the impact thereof and City staff's position was that it was consistent with the Comprehensive Plan.

Comr. Moss said it is about the bigger picture, and not this specific hotel. He believes the definition is irrelevant. He said if the City Commission is concerned about hotels vs. motels, then they should deny the item and revisit the issue.

Vice Mayor McGee asked if the Commission was interested in tabling the item.

A motion was made by Vice Mayor McGee, seconded by Commissioner Sigerson-Eaton, for discussion to direct staff to present ideas in the near future, indicating locations where hotels can be advantageous and provide language defining hotels vs. motels in the Code.

Vice Mayor McGee said multiple locations are probably good candidates for future hotel use in B-2 zoning.

Comr. Fournier stated she wants staff to work on the definition language internally.

Comr. Moss said it is becoming too complicated. He does not care for definitions and he reiterated that this request is about a text amendment that will have significant impact on the city. He said they should either postpone or vote no and have staff look into other considerations.

The parking enforcement officer can easily and quickly apply the device to the front area of the vehicle after which the vehicle owner can simply call a 1-800 number and would be provided a code to remove the device. This enforcement tool is reserved for violators with 3 or more regular citations or 1 ADA citation. The Barnacle software system is compatible with the City's current enforcement software allowing seamless report and auditing capabilities. Lastly, Mr. Lantz noted that the City offered a 60-day amnesty program, to provide an opportunity for individuals to pay outstanding parking fines to settle those fees without incurring late fees.

Mr. Harrison said that Parks and Recreation would be open to programming recommendations or requests from the Sand and Spurs Advisory Board. He reiterated that the maintenance expenses still need to remain under Public Works.

Vice Mayor McGee stated she attended the Sand and Spurs meeting last week and Public Works and Parks and Recreation are already working together. She was impressed with the Advisory Board's enthusiasm.

Comr. Moss inquired about the benefit of the proposed change. He asked if it is legal to have a City park on land that the City does not own.

Comr. Fournier said the benefit is that Parks and Recreation is better at programming and could activate the space.

Mr. Berman stated that the City owns the property, but it is deed restricted. He said that the City pays money every year into the Airpark Advisory Fund, as set up by the FAA.

Comr. Perkins asked Comr. Fournier to restate the motion. Comr. Fournier restated her motion.

Mayor Hardin stated that Public Works takes care of everything, but Parks and Recreation is responsible for programming. He said that Parks and Recreation have not been programming at Sand and Spurs recently.

Vice Mayor McGee stated there is a necessity to work directly with the Advisory Board as they do not own the horses and would want them to participate.

Comr. Sigerson-Eaton stated that Sand and Spurs could be a great asset to the community. She spoke about programs that occur at the facility in the City of Plantation. She said there is potential to host an event each season to add to the uniqueness of Pompano Beach. She spoke about future opportunities to generate revenue.

Comr. Fournier said the horse owners are not required to participate since it is open to the public. She suggested an idea like a horse-themed playground to draw more residents into the facility.

Comr. Moss understands the motion is not about Sand and Spurs Park but about moving it to Parks and Recreation. He argued that if it is moved, why should it have its own Advisory Board. He said it benefits the City to keep it the way it is.

Mayor Hardin said he understands the desire to see more activity at the facility. He advised they should leave it the way it is, but they can ask the City Manager to have Parks and Recreation setup programs for Sand and Spurs. He said that Parks and Recreation would need a separate budget line for programming. He agreed that the Parks and Recreation Advisory Board should be involved in programming.

Vice Mayor McGee agreed that there is still a lot of maintenance to address first before they can host large events. She said they currently offer lessons.

Vice Mayor McGee asked if there is a process in which the City can get out from under the deed restriction. Mr. Berman said the City Manager's Office is looking into it. He noted they tried to get out of it previously and it was denied. He said the FAA wants to make sure that existing airparks remain.

Comr. Sigerson-Eaton said the Advisory Board plays a big role with the facility.

An amended motion was made by Commissioner Fournier, seconded by Commissioner Sigerson-Eaton, to direct the City Manager to have the Parks and Recreation Department review the Sands and Spurs stables operations for additional programing opportunities and associated capital improvements to support the additional programing.

Comr. Moss' Report:

Comr. Moss said there is a proposed project to develop the Oaks Cypress Clubhouse into a residential complex, which is a controversial matter in Palm Aire. He spoke to the developers this week and they will be revising their plans. The developers will establish a website with the revised plans and include a place to solicit feedback. Next, Comr. Moss stated he communicated with Senators Pizzo and Polsky about hosting a meeting to discuss the cost of insurance and requirements to fully fund condominium reserves. He will announce the date when he has it.

Comr. Perkins' Report:

Comr. Perkins asked for an update on the Blanche Ely parking lot. Mr. Harrison replied that the staff relayed the information that the parking lot was under review with the engineer and permits were being secured. Comr. Perkins asked about the timeline for the house demolition. Mr. Harrison said he will provide any updates or information to Comr. Perkins when he has it. Furthermore, she asked for an update on the mini park to be located at the site of the proposed house demolition (420 NW 6th Street). Mr. Harrison replied he will circle back with the details.

Finally, Comr. Perkins announced a workshop at the E Pat Larkins Center on October 5th to help sealing and expungement of personal records. She said adults and juveniles with a government ID are welcome.

Comr. Sigerson-Eaton's Report:

Comr. Sigerson-Eaton thanked Mayor Hardin for attending the Cresthaven Civic Association meeting. She said it was well attended. She announced the next meeting will be held November 9th. She noted that she has been out of town and has not been able to review her recent emails.

Vice Mayor McGee's Report:

No report.

Mayor Hardin's Report:

Mayor Hardin thanked Comr. Sigerson-Eaton for the invitation to attend the Cresthaven Civic Association meeting.
