### Special City Commission Meeting

#### CALL TO ORDER

The Honorable Rex Hardin, Mayor called the special meeting to order at 4:30 p.m.

#### APPROVAL OF AGENDA

Horacio Danovich, CIP & Innovation District Director, presented the item and stated that most of the other agenda items are all academic in nature. This is a process that was included in the G.O. Bond in terms of securing design services, and currently, this is to secure Construction Manager At Risk (CMAR) for each project. Therefore, the items presented are all related to contracts that the City will enter into with each CMAR for each G.O. Bond initiative. These are “umbrella” contracts and do not have a dollar amount attached to it until the work authorization for each task is approved separately.

Continuing, Mr. Danovich explained that these set of items are just contracts and following will be work authorization number one (#1), which will be for pre-construction services, and will be treated as a separate agenda item. The Commission will approve dollars to be spent. However, at this time the Commission will only approve the contract to allow the CMAR's to assist staff to begin the process.

Once the pre-construction items are completed, the CMAR's assist to hone in on the projects to do the value engineering, to assist with procurement, to understand constructability issues, and so forth. Staff will return to the Commission with a Guaranteed Maximum Price (GMP) proposal. There is a long way to go prior to reaching this stage. In fact, there are two more steps in the process prior to commencing construction. The backup packages are very bulky, but they all contain the same standards and are identical in nature.

Mr. Danovich stated that this particular item is to award a CMAR contract for the project known as McNair Park Renovations. Consequently, Kaufman Lynn Construction, Inc. was ranked #1, for the park's agenda item. In total there are seven parks. In addition, Kaufman was ranked number one for the Kester Park as well. Therefore, he recommended approval.

Tom Terwilliger, Pompano Beach, FL, indicated that his comments will apply to all the other items on the agenda. Items 1 through 18 at the end states, “Fiscal Impact: N/A.” Mr. Danovich indicated that N/A does not say any fiscal amount and he provided the definition of N/A. It appears that if the Commission approved these items, they will be committing to spending approximately \$50 million to \$100 million of taxpayers' money, according to his guesstimate, he then provided his reasons. He requested that the Commission table the items until they could be given an estimated cost for each one of the projects, and to open it up to all competitive bidding with all contractors, not just the one contractor for each project as presented. In sum, he said the citizens may not get the best project for the best price utilizing this method.

Comr. Eaton indicated for clarification purposes, these items have already been ranked and gone out to bid.

Mr. Danovich replied yes. He clarified that each one was duly advertised as a request for qualification. There were specific panels, which included members of the public, to review each one of the packages and the credentials of each applicant. In addition, he provided details of the process to select the CMAR's at this time.

In response to Comr. Eaton's comments on these projects that were voted for by the residents regarding the G.O. Bonds issue, Mr. Danovich indicated that each of the projects and the progress being made are published every month on the City's website. Also, it shows each and every line item as funds are being spent and how much is being awarded, so the City is being very transparent.

Mayor Hardin asked if the CMAR's will be hiring subcontractors, which will be local participation to do a large part of the work, which is yet to be determined what the subs will bid for the work.

Mr. Danovich responded that it is not likely, rather it is a must. For this project, CMAR's are required to reach out to a minimum of fifteen percent of local companies, which must be awarded to companies in the City of Pompano Beach. They are tasked to procure services, as well as to ensure that they conduct workshops, and entertain job fairs and whatever is needed to make sure the local companies in the City of Pompano Beach are engaged in this project every step of the way. In sum, their role is to manage the whole operation, oversee the project, and take the risk should something go wrong.

Comr. Eaton asked if Mr. Danovich's comments regarding this item applies to each of the other seventeen items on the agenda.

Mr. Danovich responded that it applies to all equally.

Comr. Perkins asked Mr. Danovich if the City is approving at this time the contract only, why not include the dollar amounts with it.

Mr. Danovich responded that at this time the CMAR's are not being paid, instead they would have to earn it. Their first earning is the pre-construction services. He then explained the process of negotiating and awarding of the contract, which will then be brought back to the Commission for approval. In other words, if the Commission does not approve, the contract it will be voided and terminated. The same process will apply at the time of the GMP.


