# APPROVAL OF MINUTES

20-208 Regular City Commission Meeting Minutes of December 10, 2019

A motion was made by Vice Mayor Moss, seconded by Commissioner Perkins, that the Minutes be APPROVED. The motion carried unanimously.

### **APPROVAL OF AGENDA**

Mayor Hardin announced that items 16 and 19 would be postponed until January 28, 2020, City Commission meeting.

A motion was made by Vice Mayor Moss, seconded by Commissioner Perkins, that the Agenda be APPROVED AS AMENDED. The motion carried unanimously.

Mayor Hardin announced that items 2, 6, 7, and 13 would be pulled for City Commission discussion.

### A. PROCLAMATIONS

#### 20-210 Dr. Martin Luther King, Jr. Day Proclamation

Mayor Hardin proclaimed January 20, 2020 as Dr. Martin Luther King, Jr. Day in the City of Pompano Beach. Byron Hall, President of the MLK Committee was unavailable to accept, therefore, Mikelange Olbel, Vice President of the MLK Committee accepted the proclamation on behalf of the Committee members.

### **B. PRESENTATION**

20-166 Strategic Plan 2018-2023 and Action Agenda 2018-2019 Quarterly Progress Presentation. (Fiscal Impact: N/A)

(Staff Contact: Ernesto Reyes)

Ernesto Reyes, Strategic Performance Manager, made a presentation to the City Commission a copy of which is attached as Exhibit I.

Ed Phillips, 384 NW 19th Street, Pompano Beach, FL, asked about the processing of the water liability claims software.

Mr. Reyes explained one of the objectives in the current strategic plan associated with that particular goal is to invest in the upgrade of information technology hardware and software. Therefore, this action item promotes the completion of that objective. The Risk Management utilizes a software to process liability claims and this is the upgrade to provide for the continuous investment in the software.

Mr. Phillips asked for clarification on the water liability claims.

Mr. Reyes indicated he did not mean to convey "water liability claims" but rather "general liability claims."

#### C. AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard" and offered the following guidelines: Once your name is called, please come forward to the podium in front of the commission, state your name and address for the record. Speakers will be limited to three minutes to speak on any item of concern or interest, including those items pulled from the Consent Agenda. In addition, he asked speakers not to speak on any items on tonight's agenda, as they will have that opportunity to do so when that item comes forward. Lastly, he requested that speakers refrain from any emotional outbursts in either support or non-support of the speaker's comments.

#### The following persons were called to speak:

**Festival Events** - Ed Phillips, 384 NW 19th Street, Pompano Beach, FL, commended the City Manager, the Assistant City Managers, as well as the City Commission's In-Reach into the community as the MLK and Tiger Trail Festival events that are scheduled for the overall City. He is pleased to see the active participation of everyone.

<u>Charter Schools</u> - Mr. Phillips provided his opinion on Charter Schools. He is concerned that the City should not be getting into the business of Charter Schools. He also expressed concerns that decisions on schools are being made and the Education Advisory Committee was bypassed and felt this issue should have been sent to them for their review. He felt the public schools have enough competition as it is for funding and the students. While public schools may have challenges, at the end of the day, they are not "bad entities for the education of the children." In sum, he along with a number of residents he has spoken with do not want the City to get into the business of Charter Schools.

<u>Affordable Housing</u> - Marcia Barry-Smith, Director of Outreach, Government Policy & Advocacy, Habitat for Humanity, 3564 N. Ocean Boulevard, Ft. Lauderdale, FL, expressed, on behalf of Habitat of Humanity, appreciation for the City's unyielding support shown to them in their efforts to collaborate to help to create safe, affordable and sustainable housing for persons from low to moderate income, who wish to reside and work in the City of Pompano Beach.

Continuing, Ms. Barry-Smith indicated that to date, they have closed on eighteen single-family homes in the Rick Case Habitat Community. This will result in approximately \$50,000, being added to the tax rolls. All the families are making payment on their three or four bedroom homes significantly below the average rent in Broward County, of a two-bedroom for \$1,902 per month. She thanked those who attended the opening and dedication of the Bob and Cherry Taylor Park.

Finally, Ms. Barry-Smith conveyed appreciation to the Gap funding that the City and staff have provided to five of the eighteen homeowners. This funding made the difference for those homebuyers whose shortfall in income would have prevented them from achieving their dream. The funding that normally comes from the City's Office

of Housing and Urban Improvement are realized from the State Housing Initiatives Partnership (SHIP) Program. Therefore, they are asking for continued support from the City for its outreach to colleagues in the legislature, especially the Speaker of the House and the members of the Appropriations Committee to vote to demand full funding of the Sadowski Housing Trust Fund. If this funding is not realized the City of Pompano Beach stands to lose \$1.32 million, which cannot be allowed to happen.

<u>Changes to City Commission Meetings</u> - Russell T. Adams, 4015 W. Palm Aire Drive, FL, member of the Executive Board of Palm Aire United, stated that this is a committee that tries to unify the twenty three large condominium associations, which comprise the enormous Palm Aire community. They have been getting the word out about how pleased they were to have an afternoon meeting of the current Commission. He spoke on behalf of the retired residents who want to come in to speak at the time of day that they can make time for, which is in the afternoon. Therefore, they hope the Commission will continue to hold certain meetings in the afternoon as well as in the evening.

**Traffic Issues** - Sharon Chippetta, 2870 NE 22nd Court, Pompano Beach, FL, stated that it is tourist season again and her neighborhood is being inundated again with the cut through traffic. This starts from Lighthouse Point through to the avenues exiting on to 23rd Avenue and 14th Street Causeway or going further on to Atlantic Boulevard. She complained of drivers blowing their horns at stop signs, intimidating other road users, and creating possibilities for traffic accidents for the residents in the area. The traffic problem is horrendous, and the residents need to stay safe.

Mayor Hardin asked if there is a particular time during the day that the traffic appears to be worse, so Broward Sheriff's Office (BSO) can do some target enforcement.

Ms. Chippetta responded that approximately 4:30 to 5:00 p.m. would be a good target time.

Comr. Eaton mentioned that they are planning on doing a safe neighborhood improvement traffic calming pilot program in the area of Cresthaven, between 17th and 14th Avenue off 33rd south to 28th and to look at new and innovative ways to calm traffic with the hope that the methods can be taken to other areas within the City. She is very aware that cut through traffic is prevalent throughout the City and other areas; therefore, she is hoping this will produce some good results in the future.

**East Atlantic Corridor Comprehensive Corridor** - Tom Drum, 2700 NE 8th Street, Pompano Beach, FL, stated he attended the East CRA (Community Redevelopment Agency) meeting and thanked Comr. McMahon for attending and chairing the meeting. He liked what Comr. McMahon said, "I would like to go to as many meetings as I can." This shows true involvement.

Continuing, Mr. Drum stated that numerous people have approached him regarding the East Atlantic Corridor Comprehensive Plan, which indicates that all the amendments in broad principle will always apply in all circumstances. Further, it states that there is the need for 5.5 acres of open space in the ETOC (East Transit Oriented Corridor). He mentioned that the Commission is counting on staff to provide the measurements on this; however, it needs to be looked at further, and provided his reasons, which includes moving the McNab House to the Park, which he opposes. He contends that staff provided gross acres that involves portions of it to include the streets and so forth, so it is not the open space that they describe, which is undeveloped land suitable for passive recreation or conservation uses.

Finally, Mr. Drum indicated that he would provide the link to the Commission.

Mayor Hardin indicated that staff is looking into the issue brought up by Mr. Drum.

<u>Affordable Housing</u> - Erneika Mejia, Habitat for Humanity, 656 NW 14th Street, Pompano Beach, FL, stated that she is a new resident of the City of Pompano Beach, who recently purchased a home in the Rick Case Community Habitat. She indicated she could not achieve her goal without "an army of angels that have made our dream a reality, for me and my neighbors." They have already began a village where the pride of ownership is shared by the eighteen new homeowners.

Ms. Mejia thanked the City and staff for all they have done and that she, along with her family, will support the City's efforts. In sum, in memory of Bryce Gowdy, who tragically lost his life in front of a Brightline train, may his life signify how urgent the need is for affordable housing.

Land Use Plan for East Oriented Transit Corridor (ETOC) - Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, FL, mentioned that the County Land Use Plan is specific that says the East Oriented Transit Corridor (ETOC) must include 5.5 acres of open space, which does not mean park. He cited the County's Land Use Plan, page 91, "Undeveloped land suitable for passive recreation or conservation use or both." He mentioned that the ETOC currently has McNab Park with 3.0 acres, Chambers Park with .21 acres, Bill Keith with .72 acres and others with .21 acres for total open space of 3.9 acres, which is less than the required 5.5 acres for the area to be classified as a transit corridor. He alleged that the City is deficient and non-compliant and explained his opinion and reasons for this. Therefore, he urged the City Commission to place a moratorium and development stop including any permitting relative to the placement of the McNab house on McNab Park, which would increase the City's deficiency and non-compliance with the County's Land Use Plan.

Mayor Hardin indicated that he is aware that Jean Dolan, Development Services Department has looked into this matter; however, he asked her if current the City is in compliance with the County's Land Use Plan.

Ms. Dolan responded that the City is in compliance with the County's Land Use Plan, as well as with the City's own Land Use Plan. She explained that land use is in gross acres.

Mayor Hardin asked if the City is going to move the house to put itself in violation.

Ms. Dolan responded that the City would not be in violation of anything. She mentioned that this analysis was done in June 2018 and it was known then that the proposal would be in compliance.

Mayor Hardin announced if anybody has questions about this matter, to contact Ms. Dolan, who is knowledgeable and is willing to sit with residents who have questions about this. There is complete transparency in the City of Pompano Beach.

Comr. Perkins pulled the item for City Commission discussion. She requested a clear understanding of the location and proposed playground and outdoor equipment for the site.

Robert McCaughan, Public Works Director, explained this is a replacement playground for the existing equipment. The original existing equipment was taken out of service because it was deemed unsafe, because the City could no longer find parts to repair it. The playground will be enhanced to provide American with Disability Act (ADA) accessibility. In addition, the park is called the Kip Jacoby Park but more commonly known in the past as the Norwood Pines Park located on south Cypress Road. Two proposals were provided for the playground and this was the best option. Prior to installing the playground, they will put up a poster that will read, "Playground coming," as well as a picture of what it will look like.

Sharon Chippetta, 2870 NE 22nd Court, Pompano Beach, FL, asked about what equipment would be included, because at one time she played racquetball at that Park.

Mr. McCaughan, mentioned the plans and what it would look like has not yet been finalized. However, there will be slides, a walking bridge, and spinners. He said staff based its decision on looking at playgrounds where kids like to play. The main thing is that the equipment has to be safety certified and it includes the safety zone, as well as it must meet certain standards to protect kids falling off the equipment that may sustain head injury. There are different modules for young kids 4-6 year olds and 6-11 year olds. There are multiple pieces of equipment included. For example, at Novelty Park, new equipment was recently installed. Community Park has that type of equipment that is the most modern in the market.

Ms. Chippetta asked if the funding will come out of the G.O Bond projects, which Mayor Hardin responded no, and explained that this is a normal procedure of upgrading the Park's equipment.

Comr. Perkins asked while on the subject, would there be any new equipment planned for the Weaver Park.

Mr. McCaughan responded no. He stated that there are 48 playground modules across the City's Parks, and based on the age and condition of the equipment at that park it is on a replacement cycle. He is unsure of where Weaver Park is, however it would replace the existing equipment not necessarily providing more fitness, currently that is not in the plan, nevertheless it could be considered.

Mr. McCaughan confirmed that improved lighting is planned for that Park.

Mayor Hardin and Comr. McGee pulled the item for City Commission discussion. Comr. McGee asked about the Mosaic theme termed, "three installations on the overpass columns under I-95." There was a note that the City requires permits from "MOT" and she wanted to know how far along the City is with the permits. This would be like prior to flagging money for such a specific thing when reliability is on another agency.

Laura Atria, Public Art Program Manager, responded that they have not started any of the projects just yet. These were discussed, but not actually started until the City Commission approves the project.

Comr. McGee indicated that with the mosaic a whole team is involved and when money is flagged for a project such as this one, when does the team start receiving reimbursement for their time, would it be at the beginning or once the project commences moving forward.

Ms. Atria responded that it goes into contract with the artist who is in charge of providing payment to the apprentices, which is the team, and they are approved by staff and must meet certain requirements such as work, live or go to school in Pompano Beach and over the age of 18 years old. In addition, the artist must provide information that she paid them and that the apprentices have fulfilled their duties.

Comr. McGee enquired if the Commission can assist to get this moving in the event MOT does not permit it.

Mayor Hardin asked to pull the item for a quick presentation by Ms. Atria on the project, which she provided a hard copy to the City Commission along with the annual plan.

Ms. Atria mentioned how they came up with the master plan, how the program started and where they go from there. She provided a list of the projects completed in fiscal year 2019, which includes:

- The trail of the honeybees. First walking tour will be on January 25, 2020, to start at 10:00 a.m. at the Pompano Beach Cultural Center and will take one-mile trail of thirty-two mosaics with honeybees as their main theme, with different popular events at different areas within the City's cultural centers.
- A project called "Music Leads the Way," will have three large-scale mosaic murals on the Pompano Beach

Amphitheater.

- A project called "Community," which is on the Charlotte Burrie Community Center to be unveiled when the Center is opened to the public. This is a sixteen-foot mosaic mural.
- > The Oasis sculpture, which is in front of the Oasis Utility water plant.
- An artist in residency program, which took place for approximately two years in Collier City. There are two murals in the Jan Moran Public Library. A part of the mural was using residents to help create it, with their handprints on the wall.
- The 9-11 memorial located in Founder's Park. The prefabricated sculpture called, "We go Together" by famed Australian artists, Gillie and Marc Schattner.
- Round 2 of the utility wraps project has been completed. They wrapped forty-three more boxes. Currently, they are in the process of completing Round 3, after which they will finish wrapping all utility boxes in the City.

Comr. McGee pulled the item for City Commission discussion to get clarification as to the location of the project and the work planned for concrete work. She expressed concern after reviewing the aerial to see where it will be located because it is tied to the Pier and its entrance with the concrete poured being specific and costly. After seeing the plan that indicated specificity and the cost related to concrete, she became concerned. She suggested that if possible, could they consider somewhere else on the beach without destroying something that was just installed and costly.

Ms. Atria indicated that they have been discussing the matter with Robert McCaughan of the Public Works Department. The artist has already looked into the area. Originally, the pieces were done by the CRA but she has spoken with them to inform that this is a project the City is looking into. Nevertheless, Ms. Atria indicated that they are not removing all of it but instead small areas will be removed to small circular areas, approximately five, and then replace the smaller areas that are already outlined on the design. These areas will be replaced

with mosaic floor pieces. She assured Comr. McGee that they will not dig up the construction that was recently done, but will be adding to the aesthetic of the cement already in place.

David Miller, 2621 NW 13th Street, Pompano Beach, FL, and Ayanna Miller, 3504 Wildflower Drive, Coral Springs, FL, expressed thanks to the City of Pompano Beach, the Public Works Director, Robert McCaughan, and Comr. McMahon. He brought a shirt that displayed a picture of Rev. Dr. Daniel Miller for those who did not know him.

Ms. Miller stated that they felt their father was a worthy contributor to the City of Pompano Beach and Broward County. She mentioned that he was the first African-American General Contractor in Broward County. He built exclusive to low income housing from Lighthouse Point to Fort Lauderdale. He built and maintained homes throughout northwest Pompano Beach. He actually laid the plans and built homes for the Pine Tree Park subdivision. He was a founding pastor in Pompano Beach and one of the bounding members of the Pompano Blue Lodge 408. Therefore, the City needs to be aware and recognize his contributions. He was well respected and worked with the Prison Ministry as well. Notwithstanding, they respectfully requested that the City Commission consider dual name, for the benefit of the community's education and recognition of his contribution throughout Broward and especially in Pompano Beach.

Mr. Miller announced the Collier City Trail Blazer Exhibit will take place on February 8, 2020 at 3:00 p.m. at the McNair Center, when other pioneers will be honored.

Comr. McGee indicated that the City was looking into the actual costs for street renaming. In fact, she thought there was a freeze for this to determine the cost to the City versus what the process is to get the streets renamed. She then proposed, not counting the item before the Commission for approval that the City do a moratorium on renaming henceforth until costs can be determined more in line with what the actual costs are to the City.

Andrew Jean-Pierre, Finance Director, presented the item and stated that staff is recommending the City Commission's approval to modify the estimate for the Collier City neighborhood improvements project and add a new project, called FPL Light Fixtures Conversion Project. The current series 2018 G.O. Bond Project list represents estimates, which are subject to modifications and the strict guidelines. The modification better serves City purposes and the project is included in the five-year Capital Improvement Plan (CIP). The project remains within the Streets, Sidewalks, Bridges and Streetscapes project category. The estimated delivery cost for the Collier City project is \$1 million. Therefore, with the savings from the initial estimate the City can expand the design and construction of lighting system equipment to various neighborhoods to include, but not limited to, the Cresthaven and the Highlands areas.

Continuing, Mr. Jean-Pierre mentioned that the estimated costs associated with the project would be \$2 million. The City's ultimate goal is to provide safe streets and walkable areas Citywide.

Comr. Perkins asked if there are any other areas for the FPL light features other than the Collier City, Cresthaven and the Highlands areas.

Horacio Danovich, CIP and Innovation District Director, responded there are a number of areas he had planned to address on the next agenda item. He mentioned that Liberty Park is one of the areas identified as targets, and Kendall Green, Cresthaven, and the Highlands to name a few. The intent of the additional \$2 million is to focus on those that have a higher priority, which are areas that staff identified that are of dire need of supplemental lighting and to replace outdated systems.

Comr. Perkins indicated that the study that was conducted two years ago, listed the areas where lighting is needed.

Mr. Danovich mentioned that the City retained a professional engineer to look at all the areas and to identify the existing fixtures such as how many there are, what kind of coverage they have, and how unsafe they are because of lacking equipment. Therefore, they moved those high on the priority list to ensure the residents are provided with those services.

Comr. Eaton stated that District 2 is in such need of lighting from Dixie Highway to the west, NE 3rd Avenue where the only residential lighting in that specific area extending into Leisureville, then near the Crystal Lake Elementary School that entire area has no residential lighting. To the east, there is Cresthaven that has more lighting but in the center and other outlying areas is lacking in residential and street lighting. To the north, there is the Highlands, which has the most but with the conversion it will be good. She will push for the City to start this project where the need is greatest. She mentioned that there are no lights in north Kendall Green. She along with the residents in the area will be happy when the streetlights are installed in the area.

Mr. Danovich indicated two agreements have already been executed with FPL and currently working with them for agreements for Cresthaven and the Highlands that will cover all the areas that Comr. Eaton mentioned earlier. In sum, this item along with the following one, will allow staff to make the funding available to help to take care of these needs.

Comr. Eaton thanked Mr. Danovich and staff who have been working on this, as well as the City Manager for the work put into this project.

Vice Mayor Moss indicated that he recognizes the need for lighting in District 2 and he supports what is being done.

Mayor Hardin asked if Liberty Park has been funded.

Mr. Danovich responded that it is moving and they are waiting for FPL to put the work order through and then they will put it on the calendar and the work will commence on the ground.

Mayor Hardin asked if more Bond funds could be available from the same category and if there are excess funds someplace else those can be used for lighting in other areas in the City where needed.

Mr. Danovich responded that is correct.

Mayor Hardin pointed out that funds cannot be taken from one category to fund another category. For example, funds for Streets, Sidewalks, Bridges and Streetscapes cannot be used for Parks.

Horacio Danovich, CIP & Innovation District Director, presented the item and stated that in order for these projects to be eligible for funding, the \$2 million set aside in the previous agenda item, they have to be in the Capital Improvements Plan (CIP) program. This is how projects are identified not how they are managed. The requested \$2 million were originally in the G.O. Bond agenda item so now they are being transferred to this particular FPL light fixtures conversion project, which will assist to fund the additional areas that were identified as being in dire need for supplemental lighting including Cresthaven, Highlands and so forth.

Mayor Hardin clarified that this is \$2 million of G.O. Bond money that is being transferred from one project to another project. The new project is now a G.O. Bond project. They cannot take some funds from one project to help supplement the general fund. It must be used the way it is intended.

Mr. Danovich confirmed that is correct which is what staff intends to do.

Mayor Hardin reiterate the sentiments made by Comr. Eaton and Vice Mayor Moss that the areas targeted to receive lighting is well needed and it is great news that there are excess funds.

A. Randolph Brown, Utilities Director, presented the item and stated that it is the second reading of the ordinance to bring forth a future capacity for the utility and the customers of the City. This will help with plans for sustainable water supply in the future and will assist the City to sustain its wells to the east where salt water intrusion is impending on the water supply. They plan for tomorrow instead of just for today. As stated in the newspaper lately, there are many other utilities jumping on board for this reservoir.

Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, FL, stated that the backup material states, "Currently we are averaging 15.4 million gallons of water per day." He asked if the City ever came close to its maximum amount that it can draw per day.

Mr. Brown replied yes and provided the details on the monthly average set and how the process works to ensure that the City stays within the monthly boundaries of usage.

Mr. Brown explained the details on the Reuse system, which can save gallon for gallon in our water usage.

Mr. Terwilliger opined that the new development be monitored to ensure there will be enough supply for sewer and water.

Mayor Hardin asked if there is sufficient capacity on the horizon for water and sewer services.

Mr. Brown responded yes.

Comr. Eaton reiterated that all the Highlands area has reclaimed water pipes where people can hookup. It is well worth hooking up to the systems available. We will be saving the eastern wells from salt-water intrusion as well as saving potable water. If everyone could hookup this would help save the planet.

Mr. Brown announced the way to get hooked-up is to go to, Icanwater.com page, and all the information is available for signing up. All that is needed is to complete the hold harmless form, there is no upfront money and the connection is straight to the sprinkler system. The City also has a boring where the yard is not dug up for connecting to the sprinkler system.

Comr. Eaton urged everyone who has the ability to go to the reclaimed water at Pompano Beach and sign up for a hookup.

Comr. McGee echoed Comr. Eaton's sentiments in that she has learned from Mr. Brown who has explained how forward thinking the City has been with its water and sewer programs. If you are in an area that has reuse, it protects the wells, it helps with the overall aquifer and so many great things being done here in the City to be forward looking and not just worrying about the present. The utilities department is a great resource for all types of questions that anyone would have. She urged residents in the reuse areas to hookup.

Vice Mayor Moss stated it would be negligent if the City did not do this. Florida will continue to grow and later the residents will be thankful the steps are taken today because at some point in time this will be a lifesaver for us.

Mayor Hardin indicated that if this were in front of his house there would be a thousand signs up. There are people across the City wanting to get the reuse water. Therefore, this can be expanded; the better it will be for everybody. Thanks to former departed Vice Mayor Herb Skolnick, who originally pushed for the plant many years ago. This has truly been a game changer for the City. He thanked Mr. Brown and staff for the work being done to ensure that the water and sewer system is safe, secure and maintained.

Daniel Keester-O'Mills, Principal Planner, Development Services Department, presented the item and stated the proposed text amendment clarifies the principle and customary uses in Article 4, related to sexually oriented businesses. The text amendment seek to prohibit sexually oriented businesses from proposing expansions or additions to the business from other uses that maybe permitted but in the same zoning district. This is the Second Reading of the ordinance and since First Reading, a memorandum was added to the backup that provides a number of examples at adverse negative secondary effects this use can have on an area. The City seeks to mitigate these negative effects by adopting these regulations. The definition of a sexually oriented business is not proposed to be amended. The text amendment identifies certain accessory uses that maybe permitted, if the principle use is sexually oriented. At the April 2019 Planning & Zoning Board meeting the Board unanimously recommended approval of these proposed text amendments and staff is recommending approval as well.

Luke LaRue, 2240 Belleair Road, Clearwater, Florida, indicated that in June, they had expressed significant opposition to this, but as a courtesy, he wanted to inform the Commission that they have withdrawn their opposition, and from his client's B-Line Entertainment Partners, Inc., they are actually changing the principle use of that particular location. It has been a pleasure working with Mark Berman, City Attorney, to work through the processes. There was some litigation indirectly related to this matter and they have since dismissed that litigation.

M. Ross Shulmister, 560 SE 12th Street Pompano Beach, stated that in the ordinance there is a limitation on having businesses within the proximity of each other. Therefore, there cannot be two sexually oriented businesses within 1,000 feet. In addition, there is a provision that they cannot bring in a sexually oriented

business within a 1,000 feet of certain other businesses. It also prohibits bringing in those other businesses within 1,000 feet of an existing sexually oriented business. Therefore, it appears that the City wants to try to allow businesses to come in even though they come within the 1,000 feet as opposed to the sexually oriented businesses, which is being kept out. Therefore, he is suggesting that perhaps staff should check into finding a way to relax that ordinance with regard to new businesses moving in. So, that could be another way to change the "flavor" of the neighborhood from the sexually oriented business to more generally acceptable businesses.

Mark Berman, City Attorney, mentioned that the main purpose of the ordinance is to prevent other businesses from operating on the same premises of sexually oriented businesses operations. That is a sole use for a property opposition staff is working through. He pointed out that the Exhibit, which is part of the backup and the presentation, includes Item 8 in the backup that is the secondary effects of sexually oriented businesses, which has a link with approximately 4,000 pages.

Finally, Mr. Berman thanked Mr. LaRue for flying in from the West Coast of Florida to indicate that he has no objection.

Comr. Perkins asked what other type of businesses they were putting inside that business.

Mr. Berman responded that it was potentially a private club that would allow the premises to remain open twenty-four hours a day without any restrictions on the operations of the property.

Comr. Eaton asked if someone wanted to open a business, for example a sandwich shop/dry cleaner a few doors from a sexually oriented business, would they be prohibited from doing so.

Mr. Berman responded not if it is a couple doors down from the premises. In sum, no distance requirements other than businesses that would be on the premises.

Mark Berman, City Attorney explained that the nature of temporary use permit is for a minor use normally for storage of materials for construction on a piece of property that the City would not have to go through its own board. It is a very temporary use for minor and temporary, not permanent purposes. This would mean putting fewer matters before the boards on things that the City need to do for the G.O. Bond projects and other projects.

Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, FL, agrees there are temporary use permits for such things as construction trailers and so on. However, Mr. Wemyss mentioned in his comments earlier about the McNab House that it could be used as a temporary staging location. Therefore, he asked could the McNab House be placed on McNab Park as a temporary staging location.

Mr. Wemyss responded that the permit for the McNab House has been approved. He is unaware of the location of the staging, but there is an approved temporary permit for that project.

Gregory Harrison, City Manager, explained that the ordinance was written to expedite the City's own public projects that is being done under the G.O. Bond and the Capital Improvements Program for equipment and materials. This has nothing to do with the McNab House.

Mike Skversky, 1630 SW 5th Avenue, Pompano Beach, FL, asked if there is an approved temporary permit for the McNab House.

Jennifer Gomez, Assistant Director, Development Services Department responded that there is a temporary permit approved by the Zoning Board of Appeals for the McNab property. However, that is coming after the City Commission's approval of all the constructions that are for the projects.

Ms. Gomez reiterated that this ordinance is to remove the duplicative process, however, not to allow the moving of any home has nothing to do with the McNab House.

Sharon Chippetta, 2870 NE 22nd Court, Pompano Beach, FL, stated that this looks like a loophole and a little avenue that could be exploited in the future. Therefore, she urged the City Commission not to vote on this.

M. Ross Shulmister, 560 SE 12th Street, Pompano Beach, FL, indicated that the temporary use permit is not really a permit. It is a permission to use the property without having to do such things as meet landscaping requirements and other requirements that would be necessary if they were going to use the property the way they want to use it temporarily for whatever purpose. Additionally, Mr. Shulmister asked if there is any problem

with equal protection.

Mr. Berman responded no.

Mr. Shulmister indicated that this is a needed provision and urged the Commission to pass it.

Vice Mayor Moss suggested that perhaps they could change the language to "Temporary Permission" instead of using the word "permit."

Comr. Perkins indicated that while she understands the need to reduce the burden on the Zoning Board of Appeals and to expedite the process, she feels the City Commission needs to go through the process as it relates to the CRA and the City, rather than authorize staff to do it.

Earl Bosworth, Assistant City Manager, presented the item and stated that it is an ordinance to establish admission fees, operating hours and other items for the pier. Staff recommends a daily fee of \$2 for sightseeing and \$5 for fishing on the pier. Staff researched several piers in the region and across the state and the recommended rate will keep the City competitive with the neighboring cities. Mr. Bosworth provided details on the research staff put into determining the best fees to recommend to the Commission. The admission fees will generate revenue to pay for pier operations and to help offset the ongoing maintenance costs of the new pier. Item 39 is a companion item on the rates being recommended.

Corey Thompson, 2160 NW 4th Street, Pompano Beach, FL, spoke in favor of having a wonderful pier. However, he would recommend a yearly pass for the residents of Pompano Beach, for a group of three to include children at a minimum of \$40 per month and non-residents at \$50 per month.

Doris Schmidt, 305 North Pompano Beach Blvd., Pompano Beach, FL, spoke in disagreement with paying fees to get on the pier, which is the Fisher Family pier and should remain as a family pier.

Sharon Chippetta, 2870 NE 22nd Court, Pompano Beach, FL, spoke in disagreement with charging the residents a fee and that they should get free access to the pier.

M. Ross Shulmister, 560 SE 12th Street, Pompano Beach, FL, spoke in favor of the pier but said the residents should not pay to utilize the facility, which equates to a Park in the City. He can understand charging for fishing.

Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, FL, spoke in disagreement for charging residents a fee to enjoy the pier that they have already paid for in taxes.

Mike Skversky, 1630 SW 5th Avenue, Pompano Beach, FL, spoke in disagreement for charging a fee.

Tom Drum, 2700 NE 8th Street, Pompano Beach, FL, said he is between two opinions for charging a fee, and had concerns the City having to pay approximately \$300,000 in maintenance fees.

Mary Hannon, 612 S. Riverside Drive, Pompano Beach, FL, spoke in disagreement for charging the residents a fee to utilize the pier, as they have already paid through taxes. However, she agrees to charge a fishing fee to assist with the cleanup costs and the increased maintenance of the pier. She suggested other ways to realize revenues from businesses in the area without having to charge the residents fees.

Comr. McGee indicated that she has had numerous conversation with residents in District 1 regarding the pier fees structure. She asked about the charges by Lauderdale-by-the-Sea and Deerfield Beach cities.

Mr. Bosworth responded that Lauderdale-By-the-Sea charges \$2 for sightseeing and \$7 for fishing and Deerfield is \$1 for sightseeing and \$4 for fishing.

Comr. McGee agrees there is a dilemma in ensuring the residents have access to enjoy what they have paid for but at the same time to ensure that proper maintenance is carried out of the pier. Some residents are supportive of an annual pass option for local residents. She would be more open to a situation that would incorporate something that would take care of the local annual residents, as those residents that live near the beach and would utilize this on a daily basis would have to pay approximately \$60 a month for the current no cost to walk the pier. Therefore, a plan that will incorporate an annual flat pass would be more feasible for her support of this proposal for fees.

Comr. Eaton stated that she has heard from a number of residents on this "hot topic." She is aware of so many daily walkers on the barrier island to include the "snow birds" that come in for six months out of the year. She agrees that the City needs to find a balance for the residents. To explore the opportunities to provide an annual pass for a modest fee to help offset the costs.

Mayor Hardin Hardin would be open to make it free except for fishing. However, he is concerned with the control aspect. There is a need to control people going on to the pier. and due to the land being Florida Inland Navigation District (FIND), the City could not offer this pricing to its residents. Therefore, he wanted to know if the City can provide differential pricing for the pier.

In sum, Mayor Hardin would heavily be in favor of an annual pass for four persons. He was told that the Bait Shack would handle the fees and control the entrance activities. He would be open to keep the cost down and provide a plastic type business card for the annual pass.

Vice Mayor Moss indicated this subject was the topic of his weekly Saturday meetings. Most of the members attending the meeting were against the idea of charging residents of the City to go on the pier. He suggested that upon the opening of the pier the first month or for a specified period of time the entrance could be free to residents. Perhaps and annual pass could also be considered for those who will frequent the pier often enough. Also, the City could allow the hotels/restaurants to purchase passes for their customers. Further thought process can be considered after input from the public to find a reasonable medium.

Comr. McGee indicated most people talked about being set up on a monthly plan to pay for the charges and it would be a lot easier for those residents on fixed income.

Comr. Perkins agrees that the charge should be free to residents and everyone and only charge fishing fees of \$5 that could be used to offset the maintenance costs. Nevertheless, she understands the need to deter stragglers from sleeping on the pier. Also, she agrees with Vice Mayor Moss to allow a few months free for entrance and see how that works.

Comr. Eaton opined there could be more creative ways that the maintenance costs could be paid for by the business operators on the beach. Also, hotels could offer package deals to guests of their facilities. In addition, she likes the idea of opening it up for a few months for free, as well as the option of an annual pass to pay for the costs to keep the pier safe and clean.

Comr. McMahon agrees with the fee structure as presented by staff as they are comparable with the surrounding piers. It is important to charge fees to maintain the property that the taxpayer built and maintain at the highest level possible. He agrees with the first thirty or sixty days a free pass to check out the new pier and he would support an annual pass.

Comr. McGee believes that the City could get creative and inventive with how the costs could partner with other attractions throughout the City and have different levels of passes, to integrate these with activities like the water taxi, golf, Isle of Casino and so forth. Therefore, for second reading they can take another look at the options that could be available.

Mr. Harrison indicated that staff was trying to keep it simple at \$2 and \$5 for entrance and fishing fees. However, he respectfully suggested that the Commission vote on the First Reading and between the First and Second Readings staff could put their heads together to come up with some of the suggestions put forward today and present the Commission with some of those options at Second Reading. Notwithstanding, Vice Mayor Moss's suggestion is excellent and when voting on second reading it can be effective upon the opening of the pier for 30-60 days free entrance. The big thing on this is public safety and cleanliness. Vice Mayor Moss elaborated on his suggestion that on opening the entrance fee for residents could be free for a limited time but the fishing charge would stand as is upon opening day.

<u>Gregory Harrison, City Manager - Waterline Break</u>- Mr. Harrison announced that there has been a waterline break west of the Brummer Park, which was hit by a private developer. He hopes it will get back to normalcy by the time Vice Mayor Moss reaches home.

Mark Berman, City Attorney - Update on OPIOD Litigation - Mr. Berman reported that last week he met with Chief Deputy Attorney General for the State of Florida, statewide task force for OPIOD abuse along with other persons on the committee, plus attorneys from other cities and attorneys representing cities with OPIOD litigation. The Attorney General is making an outreach as part of her task force, to find out what they can do and what legislation and items they need. For example, grants from NorCan is one that is currently being received. This is medication given to revive people from OPIOD overdose. In addition, Mr. Berman indicated that he would be meeting with the Sheriff's Office and Fire Rescue personnel to determine the City's needs and suggestions. In sum, there are legal recommendations for legislation and the City will be putting a package together, since the state is making an effort to find out how they can best serve us in this regard. As meetings continue, he will provide reports to the Commission regarding progress/results of these meetings.

#### Asceleta Hammond, City Clerk - No Report.

**<u>Commissioner Rhonda Eaton - New Meeting Time</u> - Comr. Eaton stated that she enjoyed this afternoon's meeting and is looking forward to going home to have dinner.** 

<u>Unity in the Community Event</u> - Comr. Eaton reported that the Unity in the Community event has been scheduled for January 25, 2020, from 11:00 a.m. to 4:00 p.m. at the Community Park, 1801 NE 6th Street, Pompano Beach.

<u>Senate Bill 1128 on Short Term Rentals</u> - Comr. Eaton wanted to know if the City Commission would be interested to support a resolution opposing the passage Senate Bill 1128 on City not being able to regulate anything in short term rentals. She is concern if this goes forward it could erode some of the legislation that the City has enacted with simple rental home properties and it may erode the City's ability to monitor sober homes.

MOTION: A motion was made by Comr. Eaton, seconded by Vice Mayor Moss, to create a resolution opposing Senate Bill 1128 regarding short term rentals. The motion carried unanimously in favor of the resolution.

<u>Commissioner Andrea McGee - Moratorium</u> - Comr. McGee proposed that the City Commission pass a moratorium to freeze the renaming of roads/streets until the financial part in the process is understood.

Mayor Hardin suggested if it is for the City to recoup its costs for these activities then perhaps the Commissioner could make a motion to direct staff to change the procedures for the naming of streets in order to allow the costs to be increased according to the application submitted. In addition, the costs should be determined prior to placing the item on the agenda. The cost could be \$500, which is currently paid by all applicants, or to pay more whichever is greater to rename that street.

MOTION: Comr. McGee made a motion, seconded by Vice Mayor Moss, to direct staff to administrate amending the City's policy on Street renaming to ensure the applicant covers the actual costs associated with the physical renaming of the street. The motion carried unanimously.

<u>Pedestrian/Bike Friendly City</u> - Comr. McGee indicated that she did a bike route over the weekend and found some areas a bit dangerous for bikers. Therefore, she wanted everyone to be aware as the City

continues to evolve into a pedestrian/bike friendly environment, to be mindful of allowing these users enough space to travel.

<u>Commissioner Tom McMahon - Report on Events Happening Around the City</u> - Comr. McMahon reported that the Green Market was a success as there was a great turnout.

Comr. McMahon mentioned that the Art Lit event had a great turn out for their second annual event. He met several tourists that were enjoying the art, which he was surprised to see the attendance. In addition, it was great to see a number of County people participating in this event. The City collaborates with the Library for this event each year. He thanked staff for working hard coordinating these events.

<u>Commissioner Beverly Perkins - Donation of \$1,000</u> - Comr. Perkins mentioned that the Little League at Mitchell Moore had their banquet on Saturday, which she attended and they gave out a number of plaques and awards to the players and cheerleaders. She requested \$1,000 from her allocation, which she would like to give to assist in paying for the plaques and trophies because they fell short in providing these.

Gregory Harrison, City Manager noted that Comr. Perkins desires to take \$1,000 of her \$10,000 allocation for her district and give to the Youth Football team, the Chiefs.

Mark Berman, City Attorney, explained that this was designed to assist with paying for events being held for the community and has been used as such in the past. However, if the Commission votes on it now he can formalize the resolution and bring it back before the Commission for approval.

MOTION: A motion was made by Comr. Perkins, seconded by Vice Mayor Moss to contribute \$1,000 towards the Chiefs' banquet that was held on Saturday, January 11, 2020, to help to defray the cost of the banquet event. The motion carried unanimously.

**Bulk Trash Issues in the Northwest Community** - Comr. Perkins asked if the City Manager could look into doing a bulk pickup twice a week in the District 4 neighborhoods. Currently, a program is in place for residents to report illegal dumping; however, it appears not to be effective as envisioned. She indicated that she checked into various African-American neighborhoods south of Deerfield Beach to the City of Hollywood, and she did not find one neighborhood that was as bad as the northwest Pompano Beach neighborhood as it relates to trash. She is now challenged to think of creative ways to deal with the bulk trash issues that keeps accumulating in the northwest neighborhoods continuously. Mario Sontologo, Code Compliance Manager, has been great working with her to remove the trash, but after cleanup five to six days later they return to the same status of more trash pile up. Therefore, she wanted to know if there is a possibility to return to picking up bulk trash twice per week.

Mr. Harrison stated he would check into this and bring back a resolution for the City Commission's consideration as to what the additional cost would be.

Vice Mayor Moss indicated that he has the same problem in the Collier City neighborhood. He said there are 23 ways to get in and out of Collier City and a lot of the trash comes from people who zip in to dump and zip out. Therefore, he asked if the City could significantly increase the fines for illegal dumping to help to deter this

activity.

Mr. Harrison indicated that with the City Attorney's assistance, they could investigate how other cities are handling this problem and come up with suggestions for the Commission to consider.

<u>Vice Mayor Barry Moss - Streamlining Commission's Funding</u> - Vice Mayor Moss indicated that he was hoping to have a dialogue on the way the City Commission get their funds from their \$10,000 allotment. He is planning two events in February in his community and he has to submit a request for certain amount of money, however, the amounts needed are undetermined at this time. Perhaps this could be streamlined to make it easier for everyone and this could also go towards more than just community events.

Mr. Harrison indicated that he would meet with the City Attorney to see if they could come up with better language that will give the Commission more flexibility.

**Town Hall Meetings** - Vice Mayor Moss announced that on Thursday, January 30, 2020, at 7:00 p.m. at the Herb Skolnick Center, the Palm Aire United group is sponsoring a Town Hall meeting about the Lakes and Trails in Palm Aire. Wade Collum, City Arborist, will be speaking on the types of trees that are located in Palm Aire and the types that they should be planting, the benefits of the different types of trees, as well as vegetation that will attract wildlife such as butterflies. Someone will also be talking about the wildlife that is in the area. In addition, they have approximately twelve miles of walking and cycling paths and they would like to do a better job of informing other residents in the City about this.

Additionally, Vice Mayor Moss announced that he would be holding a Town Hall meeting on Thursday, February 6, 2020, at 7:00 p.m. at the Herb Skolnick Center, regarding voting, the census and other community items.

<u>Mayor Rex Hardin - MLK, Jr. Parade</u> - Mayor Hardin reminded everybody about the MLK, Jr. Parade coming up on Monday, January 20, 2020, to start at 8:00 a.m. at the Mitchell Moore Park. He invited everybody to come out and enjoy a very great event.

<u>Upcoming Events</u> - Mayor Hardin announced that the Tiger Trail Festival will take place next month and that there are a number of other events going on, such as a Black Tie Gala, a 5-K Run, Collier City Trail Blazers out of McNair Park, Tiger Trail festival and Gospel Fest to take place at the Cultural Center. He noted that there are many activities planned to include Art Events with a few artists opening next door to the Cultural Center and more to come at the BaCa and Ali Centers. In sum, there is something available for everybody. Therefore, he invited all residents to get involved with these various activities and events.


