## **Summary Explanation/Background:**

November 13, 2018, City Officials approved resolution number 2019-38 authorizing the Utilities Department to apply and accept the State Revolving Fund (SRF) loan for the four existing drinking water interconnects. The original agreed amount was \$496,400. The disbursement process is now complete. The state forwarded Amendment 4 for signatures to finalize the process.

The total amount has been reduced by \$93.610.00 which will adjust the project costs and finalize the semiannual loan payment.
