Summary Explanation/Background:

Staff is seeking approval of a contract between the City of Pompano Beach (“City”) and Kimley-Horn and Associates, Inc. (“KHA”) in the sum of \$576,779 to provide professional services for the G. O. Bond funded project “McNab Road Improvements” (see Location Map). This project was duly advertised as E-16-18 Design and Consulting Services for Five Bridges within City Limits and KHA was ranked no. 2. The City Commission approved the rankings on 1/8/2019.
