**Summary Explanation/Background:**

The resolution is for the city to submit a grant proposal in the amount of \$250,000 to the NFL Foundation Grassroots Program for the purpose of obtaining funds for the football field segment of the Mitchell/Moore Park upgrade project, which is part of the G.O. Bond. The G.O. Bond Project will be the source of the required 1 to 1 match of the grant proposal and the city will be partnering with the nonprofit Oasis of Hope Community Development Corporation, Inc. The city's contribution for the project will be in an amount up to \$500,000. The resolution authorizes the City Manager to accept the funds if awarded and execute all appropriate documents.
