Summary Explanation/Background:

Staff is seeking approval of a contract between the City of Pompano Beach (“City”) and Kimley-Horn and Associates, Inc. (“KHA”) in the sum of \$2,495,340 to provide professional services for the G. O. Bond funded project “Dixie Highway Improvements” (see Location Map). This project was duly advertised as P-33-18 Planning and Design Services for the Dixie Highway Streetscape Improvements Project and KHA was ranked no. 1. The City Commission approved the rankings on 11/13/2018. Attached is a copy of the contract documents including the proposed Scope of Work (Exhibit “A”) submitted by the firm and reviewed by staff for accuracy and completeness.
