**Summary Explanation/Background:**

This twenty-eighth Amendment to the FDOT Maintenance Memorandum of Agreement (MOA) allows the adjacent property owner, SoleMar Condominium, to make certain landscape improvements to State Road A1A (North Ocean Blvd) right of way fronting their property. These enhancements will be maintained to FDOT standards by SoleMar ensuring landscaping will be aesthetically pleasing and safely maintained such that motorists' visibility is not obstructed and vertical clearance is maintained for pedestrian, bicyclist and truck traffic.
