## **Summary Explanation/Background:**

Creating a Supplemental Retirement Benefit for Police Officers to be funded solely from premium tax revenues

received by the city pursuant to Chapter 185, Florida Statutes. This ordinance does not provide for disbursement of the proceeds in the Share Plan due to current disagreement between the parties as to the distribution. We are solely establishing the Share Plan at this time as required by state statute and distribution will be deterimined later by either the Division of Retirement or by agreement of the plan members. Thus, additional revision of the ordinance is possible at a later date.
