### Summary Explanation/Background:

The City of Pompano Beach issued Request For Proposal (RFP) E-13-17 to establish an annual contract for the as-needed purchase of unleaded gasoline and diesel fuel. The City issued this RFP as the lead agency, on behalf of our City and thirty-eight other governmental agencies in the Southeast Florida Governmental Purchasing Cooperative. The City Commission approved the ranking order, and authorized the City staff to negotiate and enter into a contract with the highest-ranked firm Port Consolidated Inc. The contract, which shall commence on April 1, 2017, has a 3-year term with one 2-year renewal. The total annual value of this contract

award based on the combined estimated annual quantities of the thirty-eight participating co-op agencies, and the City of Pompano Beach, is \$32,000,000.00. Based upon the unit prices proposed, and the City's estimated usage, the City of Pompano Beach annual expenditures for unleaded gasoline and diesel fuel could total \$660,000.00. Through negotiations with the vendor, the City's Contract Manager successfully negotiated a reduction of approximately \$850,000.00 for gasoline and diesel for the participating co-op agencies and the City over the expected five year life of the contract.
