### Summary Explanation/Background:

To date, subject code has limited the City to expending funds reserved in the cemetery perpetual care fund exclusively for capital improvements. There are other necessary cemetery operational expenses that could benefit from using the perpetual care fund instead of expending from the general fund, such as the purchase of bronze grave markers and landscape replacement. Another proposed change in the ordinance is approval to begin selling concrete burial vaults, which could be purchased from the perpetual care fund if this ordinance revision is approved. Both grave markers and vaults are sold to earn cemetery revenue. During the first reading, a motion was made to remove reference to hours in Section 92.06 "Cemetery Hours." Additionally, Staff received direction to clarify Section 92.65 "Monuments," to distinguish the select locations within the central lawn where monuments are allowed.
