Summary Explanation/Background:

This item involves seeking City Commission Approval to execute a First Addendum to the Lease Agreement between the City of Pompano Beach and Pompano Aviation II, LLC as Assignee for Parcel "AAAA" (Five Acres) at the Pompano Beach Airpark. This addendum allows for Pompano Aviation II, LLC to secure a long term lease which enables them to invest at least \$3,000,000 to develop Parcel "AAAA" in order to provide aeronautical services to all users and tenants of the Airpark. Fiscal Impact \$50,094/annually

Origin of request for this action: Air Park
