Summary Explanation/Background:

City Commission previously approved ranking order for RLI E-01-18 and authorized staff to negotiate contracts with the two highest ranked professional consulting firms, Kimley-Horn and Keith and Schnars.

City Commission approval is requested to execute contract with Keith and Schnars to provide professional consulting services to the City for the undergrounding of overhead utilities on an as needed basis for various City projects for which design fees will not exceed \$200,000 and construction costs will not exceed \$2 million.
