Summary Explanation/Background:

The City of Pompano Beach solicited Bid E-10-18 to provide inspections of the Stormwater systems and to provide on call Jet Vactor Truck services. The bid was awarded to Tele-Vac South and approved by the Commission April 24, 2018. This is a five-year contract and is not subject to renewal.

Tele-Vac South has been in operation for over 25 years and is a Pompano Beach based company.
