**Summary Explanation/Background:**

This agenda item proposes the addition of a new section (Section 77) to the City's Code of Ordinances to regulate the operation of valet services within the City in order to ensure the safety of the City's residents and the general public, as the demand for valet services grows with development and redevelopment activity throughout the City. Please refer to the attached memorandum for detailed discussion. This item further amends Sections 76 and 155 of the City's Code in order to streamline the location of valet regulations within the City's Code of Ordinances.

Please note that this item has been amended from its 1st reading on January 8, 2019. Recommended changes by the City Attorney's Office have been highlighted in yellow, with the recommended changes intended to provide for the following:

1. Businesses that utilize or provide valet services for their patrons or invitees must ensure that the valet operator is licensed. Failure to use licensed operators will be a violation of the Code and may be cited as such by Code compliance officers.
2. Applicants for valet operator's license must provide proof (an executed contract or equally reliable document) of authority to provide valet services at a proposed location.
3. Valet Operators whose licenses are suspended or revoked may be arrested by law enforcement officers if found operating despite such suspension or revocation.
4. Valet Operators that conduct valet services without obtaining a permit may also be arrested by law enforcement officers.
