Lin International ("TY") in the sum of \$549,914.27 to provide professional services for the G. O. Bond funded project "Palm Aire Neighborhood Improvements" (see Location Map). This project was duly advertised as E-16-18 Design and Consulting Services for Five Bridges within City Limits and TY was ranked no. 1. The City Commission approved the rankings on 1/8/2019.
