Summary Explanation/Background:

Staff is seeking approval of a contract between the City of Pompano Beach ("City") and T. Y. Lin International ("TY") in the sum of \$439,278.48 to provide professional services for the G. O. Bond funded project "SE 5th Avenue Bridge Improvements" (see Location Map). This project was duly advertised as E-16-18 Design and Consulting Services for Five Bridges within City Limits and TY was ranked no. 1. The City Commission approved the rankings on 1/8/2019.
