Summary Explanation/Background:

Staff is seeking approval of a contract between the City of Pompano Beach ("City") and West Construction,

Inc. (“West”) in the sum of \$1,463,200 to provide turnkey services for the G. O. Bond funded project “Beach Lifeguard Headquarters Renovation” (see Location Map). This project was duly advertised as T-03-19 Ocean Rescue Building Interior Upgrades and Construction of Lifeguard Stations and West was the only responsive, responsible bidder. Attached is a copy of the contract documents including the proposed Scope of Work (Exhibit “A”) submitted by the firm and reviewed by staff for accuracy and completeness.
