Summary Explanation/Background:

Staff is seeking approval of a contract between the City of Pompano Beach (“City”) and West Construction, Inc. (“West”) in the sum of \$5,746,702.82 to provide design build services for the G. O. Bond funded project “Fire Station #61 in Northwest Community” (see Location Map). This project was duly advertised as Bid P-32-18 Construction of Fire Stations 52, 61, 114 and West was selected by a panel a reviewers to provide the aforementioned services for this station.
