Summary Explanation/Background:

This item proposes amendment by referendum of the City's Charter to accomplish several matters:

- 1. Change municipal election dates, extend current terms;
- 2. Expand district commissioner terms of office;
- 3. Stagger terms.

Pompano Beach residents will determine if they approve of these Charter changes at a Special Municipal Election to be held on March 10, 2020.

Origin of request for this action: City Commission

Fiscal impact and source of funding: \$55,000.00. The funds will derive from the 2020 budget and will be expended from the election fund.
